PRIZES TENABLE IN ALL FACULTIES

Alumni Association in Malaysia and Singapore Jubilee Prizes

The Alumni Association in Malaysia and Singapore had donated a sum for the establishment of two prizes. The prizes are to be awarded annually to the best undergraduate sportsman and sportswoman of the year.

Award for Outstanding Research Postgraduate Student

In 2002, the Graduate School established an award to give due recognition to research postgraduate students who have submitted a thesis of exceptional quality and have demonstrated outstanding performance in other academic aspects. Students shall be nominated by the relevant Faculty Higher Degrees Committee to be considered for the award. The Award shall be in the form of a certificate and book prize.

HKU-Simon K.Y. Lee Hall Social Responsibility Prize (Current Affairs)/HKU-Simon K.Y. Lee Hall Social Responsibility Prize (Social Service)

In 2012, Mr Tam Man-tat, one of our Alumni, agreed to donate \$2,000 annually for the establishment of two prizes to recognize the achievements of hall mates of Simon K.Y. Lee Hall in the areas of promoting awareness of current affairs and social participation.

Hong Kong University Alumni Prizes

In 1971, the Hong Kong University Alumni Association donated to the University a sum of \$12,000 for the establishment of a number of prizes. The donation was increased to \$20,000 in 1981, \$25,000 in 1985, \$28,000 in 1987 and \$32,000 in 1989. In 2006, the Alumni Association agreed to revise the terms for the Prizes such that one prize shall be awarded to students from each of the Faculties (currently there are ten Faculties) with effect from the 2005–06 academic year.

Li Ka Shing Prizes

In 1990, Dr Li Ka Shing made a generous donation to the University. It was agreed that a part of the investment income earned on the donation be used to establish two prizes, one for a PhD thesis and one for an MPhil thesis, for award annually in and after 1992–93. The number of prizes has increased to two MPhil and four PhD theses every year starting from 2005–06.

Lim Peck Siu Prize for the Promotion of Cultural Activities

To commemorate the fifteenth anniversary of Simon K.Y. Lee Hall in November 2000, the Hall has established a prize in memory of Mr Lim Peck Siu, maternal grandfather of Dr Max Hui-Bon-Hoa, Warden of Simon K.Y. Lee Hall. The prize of the value of \$1,000 shall be awarded to the hallmate who has made the greatest contribution in cultural activities.

Lin Guo Kai Award for the Promotion of Sports Activities

In 2001, Mr Lam Kin who served as the manager of the Simon K.Y. Lee Hall from September 1994 to December 2000, donated a prize in honour of his father, Mr Lin Guo Kai, to be awarded annually with effect from the academic year 2001–02, to a hallmate in the Simon K.Y. Lee Hall who has made the greatest contribution to the promotion of sports activities for the year concerned.

Dr Max Hui-Bon-Hoa Prize for the Promotion of Internationalization in Hall

In September 2006, the Warden of Simon K.Y. Lee Hall, Dr Max Hui-Bon-Hoa, offered to donate an annual sum of \$1,000 for the establishment of a Dr Max Hui-Bon-Hoa Prize for the Promotion of Internationalization in Hall at the University for award to a student-resident at the Simon K.Y. Lee Hall who has contributed significantly to the promotion of internationalization in Hall. The Prize forms part of the Simon K.Y. Lee Hall education prize series (subsequent to the formation of the Lim Peck Siu Prize for the Promotion of Cultural Activities, Lin Guo Kai Award for the Promotion of Sports Activities, Simon K.Y. Lee Prize for Service and C.K. Leung Award for Academic Achievements, and Simon K.Y. Lee Hall Alumni Association Prize for the Most Outstanding Student of the Year) to establish ‘internationalization’ as another core area in Hall education.

Peter Whyte Award

Peter Whyte Award was established in 2004 in recognition of the inaugural Dean of Students. The award shall be granted with effect from the 2004–05 academic year for an initial period of 10 years to HKU undergraduate students who have contributed most meaningfully to the interaction between the University and the student population.

Self Enhancement Cultural Awards

In conjunction with the objective of ‘Celebrating Diversity at HKU’, the Self Enhancement Cultural Awards, aiming to encourage students’ pursuit in arts and cultural development, will be presented to students planning to increase their understanding and experience in the arts and culture of other countries through short exchange programmes or overseas visits. With effect from 2003–04, two to four awards of the value of \$20,000 each shall be awarded each year to full-time undergraduates in the first or second year of study (or to those in their next-to-final year of study) in any discipline on the basis of academic merit and the quality of the proposal.

Simon K.Y. Lee Hall Alumni Association Prize for the Most Outstanding Student of the Year

To commemorate the fifteenth anniversary of Simon K.Y. Lee Hall in November 2000, the Hall has established a prize of the value of \$1,000 to be awarded to a hallmate who has lead a balanced hall life, that is, someone who has actively participated in hall activities and has performed well in his/her academic work.

Simon K.Y. Lee Prize for Service

C.K. Leung Awards for Academic Achievements

To commemorate the tenth anniversary of Simon K.Y. Lee Hall in 1995, two prizes of the value of \$1,000 each were established for award to students in the Hall. In 2000, the terms of agreement for the C.K. Leung Awards for Academic Achievements were revised such that two gifts of the value of \$500 each shall be awarded to a science or engineering student, and a student in a discipline other than science or engineering. In June 2009, the value of the two awards was increased to \$1,000 each.

Swire Hall Warden's Award for the Most All-rounded Student of the Year

To mark the 25th Anniversary of Swire Hall in the year 2006, Dr S.X. Zhao, the Warden of Swire Hall, has offered to establish an award for the residents in Swire Hall to give recognition to Swirians for their active participation and excellence in all-rounded performance. The award is in the form of a monetary gift of \$2,000 to be donated personally by the Swire Hall Warden or from the Swire Hall Education Fund, together with a certificate.

The Tang Essay Prize

In August 2006, Ms Violet Tang offered to donate prizes to the University as an expression of her wish to extend strong support of the University's continued promotion *inter alia* of a broad and general education, and to encourage students to enhance their articulation in written English, the principal teaching medium of the University of Hong Kong. Each year a prize of \$25,000 will be awarded to one full-time undergraduate student in each of the two Faculties listed in the Schedule. (In addition to these prize awards to the students, a donation of \$5,000 will also be made to each of the participating twin-Faculties in a given academic year, towards their purchase of resources such as books.)

Zung Fair Foundation Book Prizes

Two prizes of \$500 each are awarded annually to two second-year undergraduates who have achieved outstanding results in their First Examination, but have been unsuccessful in their candidature for a Hong Kong Association of University Women Scholarship. In 1997, the donor increased the value of the two book prizes to \$3,000 each.

PRIZES TENABLE IN THE FACULTY OF ARCHITECTURE

Autodesk HK BIM Award

In May 2011, Autodesk Far East Limited agreed to donate a trophy (maximum up to three trophies) to the University annually. The Autodesk HK BIM Award will be awarded to students studying in the programme of Master of Architecture (MArch) who take the course of 'ARCH6130 Building information modeling in architectural practice' or 'ARCH6131 Introduction to building information modeling and management', and can demonstrate outstanding use of the BIM technology in their study.

Belt Collins International (HK) Limited Travelling Scholarships

In October 2011, Belt Collins International (HK) Limited generously offered to donate to the Division of Landscape Architecture two travelling scholarships for the 2011–12 academic year to provide students of the Division with the opportunity to enrich their learning experience with respect to culture and landscape architecture through travel to places outside of Hong Kong in the upcoming summer semester 2012. Two scholarships of \$13,750 each shall be awarded to current MLA Year One students.

Building Management Prize

In 1978, Mr John H.P. Lok of the John Lok & Partners Ltd. donated an annual sum of \$500 to the University for the establishment of a prize to be awarded annually. In 1986, Mr Lok increased the value of the prize to \$1,000 and donated a sum of \$10,000 for the award of the prize for ten years from 1986–87. In 1987, Mr Lok donated a silver-plated cup for retention by the Department of Surveying, and ten small cups to be awarded to the recipients of the prize. In 1991, Mr Lok further agreed that the prize be awarded to the best student completing the MSc(ConstProjectMan) degree. In 1997, the donor extended the award for a further ten years with a donation of \$20,000.

CIHAPB/HKIH Prize

Since 2000, Chartered Institute of Housing Asian Pacific Branch (CIHAPB) and the Hong Kong Institute of Housing (HKIH) have been presenting an annual award to the best student graduated from the Professional Stream of the Master Degree in Housing Management of the University during the Joint Annual Dinner around November each year. In 2012, both Institutes agreed to establish an annual prize to be awarded to the aforesaid course from the academic year 2011–12.

David Wong Memorial Prize

In 1978, a group of University of Hong Kong architecture graduates donated a sum of \$5,000 to the University for the establishment of a prize in memory of Mr David Wong.

Fosroc Prize

In 1982, Expandite Limited increased the value of a prize, originally donated in 1965, to \$250 to be awarded annually to an undergraduate in architecture. In 1987, the prize was increased to \$500 and in 1993, the sum was increased to \$1,000 following the establishment of Fosroc Expandite Limited.

Gammon Construction Limited Prizes in Building Technology and Civil Engineering

Gammon Building Construction Ltd. donated \$1,500, \$3,500 and \$2,000 to the University in 1979, 1981 and 1985 respectively for the establishment of prizes in building technology and civil engineering. In 1990, the Gammon Construction Ltd. extended the prizes for a further period of five years. In 1996, the donor extended the prizes for a further five years with an additional donation of \$2,400. The donation was increased to \$2,500 in 1997. In 2000, the donor extended the prizes for a further five years from 2000–01 to 2004–05 with a donation of \$2,500. In 2002 and in 2005, the prizes were re-named as the Gammon Skanska Limited Prizes in Building Technology and Civil Engineering and the Gammon Construction Limited Prizes in Building Technology and Civil Engineering respectively to reflect the change of the company name. In 2006, the donor agreed to extend the prizes for a further five years from 2005–06 to 2009–10 with a donation of \$2,000.

HKIA Student Medal

The HKIA Student Medal shall be awarded annually to final-year Master of Architecture student(s) of the Faculty of Architecture of the University of Hong Kong and/or the School of Architecture of the Chinese University of Hong Kong.

Ho Fook and Chan Kai Ming Prizes

Two prizes of the value of \$350 each are awarded each year. In 1998, the value of the two prizes was increased to \$700 each.

Hong Kong Institute of Architects Student Medal

In 1979, the Hong Kong Institute of Architects donated a prize in the form of a student medal for award annually until further notice.

Hong Kong Institute of Landscape Architects – Student Award of Excellence

In September 2011, the Council of the Hong Kong Institute of Landscape Architects (HKILA) generously offered to donate to the Division of Landscape Architecture three annual student scholarships, to recognize excellence in the work of the students of the Master of Landscape Architecture programme. Two scholarships of \$5,000 each shall be awarded to two students of the current Master of Landscape Architecture Year Two Class, and one scholarship of the value of \$5,000 for one student of the current Master of Landscape Architecture Year One Class.

Hong Kong Institute of Planners Prizes

In 1984, the Hong Kong Institute of Planners donated funds for the establishment of two prizes to be awarded to students reading for the degree of MSc(UrbanPlanning).

Hong Kong Institute of Real Estate Administration Prizes

In 1998, the Hong Kong Institute of Real Estate Administration donated three prizes for 1998–99. For BSc(Surv) I and II students, the prizes are of the value of \$5,000 each and for BSc(Surv) III students, the prize is of the value of \$10,000. In 2000, the donor continued the prizes from 1999–2000 onwards.

Hong Kong Institute of Surveyors Prize

In 1988, the Hong Kong Institute of Surveyors donated until further notice a sum of \$2,500 per year for the establishment of a prize to be awarded annually to a student entering the second year of the BSc(Surv) curriculum. The Institute increased the value of the prize to \$3,000 from 1990–91. In 1997, the Hong Kong Institute of Surveyors increased the value of the prize to \$8,000 with effect from the 1997–98 academic year. In 2005, the prize shall be awarded annually to a maximum of two students entering the second year of the BSc(Surv) curriculum. In June 2007, the prize award was divided equally between students entering the second year of the BSc(Surv) curriculum, and graduates of MSc(RealEst) majoring in General Practice Surveying and MSc(ConstProjectMan) majoring in Quantity Surveying, on the basis of academic merit.

J.H. Kinoshita Prizes

In 1979, Mr J.H. Kinoshita donated a sum of \$10,000 for the establishment of two prizes in architectural design in the form of books to be awarded annually. In 1985, a further donation of \$10,000 was added to the fund and the number of prizes was increased to three each year.

Professor K.C. Lye Design Prize in Architecture

The Professor K.C. Lye Design Prizes in Architecture was established in 2000 with donations from friends and former students of Professor K.C. Lye for the award of the prizes to students who have excelled in Architectural Design in the Department of Architecture of the University Hong Kong.

Leigh & Orange Design Prize

In 2008, the Board of Directors of Leigh & Orange Ltd. offered to donate a prize to the University of Hong Kong annually from the academic year 2008–09. The value of the prize shall be \$20,000.

Levett and Bailey Prize

In 1979, Levett and Bailey, Chartered Quantity Surveyors, donated a sum not exceeding \$300 a year to the University for the establishment of a prize in Building for five years, and in 1982, extended this prize for five more years. In 1988, Levett and Bailey continued to offer the prize for another term of five years up to 1993, and to increase the value of the prize to not exceeding \$500 a year. In 1993, the donor continued the scheme for a further five years to 1998, with the prize value increased to a sum not exceeding \$700 per year. In 1997, the donor extended the prize for another five years from 1998–99 and increased the value of the prize to \$1,000. In 2003, the donor agreed to extend the award of the prize for another five years from 2003–04 and the value of the prize would not exceed \$1,000 per year.

Minnette de Silva Prize

In 1980, Miss Minnette de Silva donated a sum of \$3,000 to the University for the establishment of a prize.

Sir Ove Arup Prize for Structures

In 1978, Sir Ove Arup, CBE, DSc, FICE, FStructE, of Ove Arup and Partners of Fitzroy Street, London, donated a book prize to be awarded annually for twelve years. In 1990, the Company continued to donate this prize until further notice.

Real Estate Tech Prize

In March 2009, Mr Stephen Chung and Mr K.K. Wong of Zeppelin Real Estate Analysis Ltd., both HKU alumni, agreed to donate a sum of \$10,000 to the Department of Real Estate and Construction, for the establishment of prizes to outstanding first-year surveying students.

Royal Institution of Chartered Surveyors Prize

In 1987, the Royal Institution of Chartered Surveyors provided a prize from 1988 until further notice to be awarded annually to a student in any year of the BSc(Surv) curriculum. In 1991, the Royal Institution of Chartered Surveyors increased the value of the prize to £30 from 1990. In 1994, the donor increased the value of the prize to £40 which shall be in the form of a book token.

The Royal Town Planning Institute Book Prize

In 1987, the Royal Town Planning Institute established an annual book prize to be awarded from the 1987–88 academic year onwards. The prize shall be awarded to a student who is in his/her final year of studies achieving the highest mark in the MSc(UrbanPlanning) dissertation.

The University of Hong Kong Surveying Alumni Association Prize

In 2002, the University of Hong Kong Surveying Alumni Association offered to donate from 2002–03 onwards, one prize of the value of \$1,000 per annum for award to the final-year student pursuing the BSc(Surv) who has attained the highest mark in the Dissertation.

Walter Gropius Student Medal

In 1981, Professor K.C. Lye donated to the University a prize in honour of Dr Walter Gropius.

Y.M. Wong Memorial Prize

In 1981, the family of the late Mr Y.M. Wong donated a sum of \$10,000 for the establishment of a prize.

Dr Anita Chan Lai Ling Prizes in Chinese Culture

In 2001, Dr Anita Chan Lai Ling, MBE, JP, made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2001–02, to the student with the best results in the course 'CHIN1204/YCH10002 Chinese culture in the twentieth century' and the other to the student with the best results in the course 'CHIN1207/YCH10001 Traditional Chinese culture'.

The Atlinks Prize in French

In the 2000–01 academic year, the Atlinks Prize in French was established through the generous donation of Atlinks Hong Kong Ltd. for the purpose of supporting of students of the University of Hong Kong in their language training programme in France in the summer months. One prize of the value of \$7,500 shall be awarded on the basis of academic merit to a second year undergraduate who is studying the French language.

Bernard Van Zuiden Prize

In 1986, the Trustees of the Bernard Van Zuiden Music Fund donated a prize to be awarded annually to an undergraduate commencing the third year of the BA curriculum reading no fewer than six courses in music. In 1996, the Trustees agreed to increase the value of the prize to \$10,000. In 2006, it was agreed that the Prize shall be awarded to an undergraduate commencing the third year of the BA curriculum reading no fewer than 48 credits in music in their second and third year of his/her studies.

Ms Cecilia Vong Prize in Linguistics

In 2011, Ms Cecilia K.P. Vong, a HKU graduate, donated to the University a sum of \$50,000 for the setting up of a prize to be awarded annually from the academic year 2011–12 to Linguistics students. The prize of \$1,000 shall be awarded to students in the final two years of study of the Linguistics programme.

Ms Cecilia Vong Prizes in African Studies

In 2011, Ms Cecilia K.P. Vong, a HKU graduate, donated to the University a sum of \$50,000 for the setting up of two prizes to be awarded annually from the academic year 2011–12. Two prizes of \$1,000 each shall be awarded to the graduate students with the best results in African Studies courses in each year of study.

Chan Wing Kan Prize in Chinese Language

In 2001, the Chan Wing Kan Trustees Incorporated made a donation of \$50,000 to establish a prize to be awarded annually from the academic year 2001–02, to the student with the best result in the course 'CHIN1101 A survey of the Chinese language'.

Chan Wing Kan Prize in Chinese Language and Literature

In 2003, Mr Chu Hon Sang, Chairman of the Chan Wing Kan Trustees Incorporated made a donation of \$50,000 to establish a prize to be awarded annually from the academic year 2003–04, to a second-year student with the best results in Chinese Language and Literature.

Charles and Lillian Moore Memorial Prize in Philosophy

In 1982, Professor F.C.T. Moore of the Department of Philosophy donated a sum of \$5,000 for the establishment of a prize in philosophy in memory of his parents.

Cheung Nim-ping Prizes in Chinese Literature

In 2001, Mr Cheung Nim-ping made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2001–02, to the student with the best results in the course 'CHIN102 An introduction to standard works in classical Chinese literature' and the other to the student with the best results in the course 'CHIN1103 An introduction to standard works in modern Chinese literature'.

*Chin Chung Chu Prize in Chinese History and
Chak Ping Har Prize in Chinese History*

In 2004, Ms Kam Pun Pun kindly made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2004–05, with one of the prizes for award to the student with the best results in the course 'CHIN2257 The development of Confucianism in late imperial China' (Chin Chung Shu Prize in Chinese History) and the other to the student with the best results in the course 'CHIN2259 Historical writing and historiography in traditional China' (Chak Ping Har Prize in Chinese History).

Chiu Ling Yeong Prize in Chinese History

In 2003, Dr Ip Sau Sheung kindly made a donation of \$50,000, of which \$25,000 shall be used to establish a prize to be awarded annually from the academic year 2002–03 to a first-year student with the best results in Chinese History.

Chong Chi Kong Prize in History

In 1978, Mr Peter Chong Lap Chuen of Hong Kong donated a sum of \$5,000 for the establishment of a prize.

Comitato della Dante Alighieri di Hong Kong Ltd. Book Prize

In 2009 the Comitato della Dante Alighieri di Hong Kong through the Consulate General of Italy offered to establish a prize in the form of book token to the most outstanding student(s) of the School of Modern Languages and Cultures to reward his or her achievements and interest in the study of Italian.

The Consular Book Award in American Studies

In 2010–11, the American Consulate General, Hong Kong agreed to establish a book prize of \$5,000 for outstanding student(s) in American Studies.

Consulate General of Italy Book Prize

In 2009 the Consulate General of Italy offered to establish a prize in the form of book token to the most outstanding student(s) of the School of Modern Languages and Cultures to reward his or her achievements and interest in the study of Italian.

Consulate General of Sweden Book Prize

In 2009 the Consulate General of Sweden offered to establish a prize of about \$5,000 to the most outstanding student(s) of the School of Modern Languages and Cultures to reward his or her achievements and interest in the study of Swedish.

Ding Richang Prizes in History of the Qing Period

In 2001, Dr Joseph Sun Pao Ting made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2001–02. The prizes shall be awarded to the two students with the best results in the course 'CHIN2226 History of the Qing Period'.

The Dragages Prize in French

In the 2000–01 academic year, the Dragages Prize in French was established through the generous donation of Dragages et Travaux Publics (HK) Ltd. for the purpose of supporting of students of the University of Hong Kong in their language training programme in France in the summer months. One prize of the value of \$7,500 shall be awarded on the basis of academic merit to a second-year undergraduate who is studying the French language. In 2004, the name of the company was changed to 'The Dragages Hong Kong Limited', and the value of the prize has been revised to \$5,000. In 2005, a further donation of \$5,000 was received from the donor to support the continuation of the prize award.

Ellis Bell Prize in English Literature and Comparative Literature

In 1977, an anonymous donation of \$8,000 was received by the University for the establishment of a prize.

External Examiner's Book Prize in Philosophy

In June 2000, the External Examiner of the Department of Philosophy offered to donate a book prize of the value of \$250 to a student from the 1999–2000 academic year onwards.

F.S. Drake Prize in Chinese

To commemorate the seventieth birthday of Professor F.S. Drake (Emeritus Professor of Chinese and former Director of the Institute of Oriental Studies) in April 1962, members of the Chinese staff of the Department of Chinese and of the then Institute of Oriental Studies, graduates in Chinese since 1953, together with friends of the University, raised a fund of over \$5,000 for the establishment of a prize.

Falling Leaves Foundation Prize in Cross-Cultural Studies in English/English Literary Studies

In 2010, Falling Leaves Hong Kong Foundation offered to endow one prize in Cross-Cultural Studies in English or English Literary Studies by donating a capital sum of \$100,000 to the University of Hong Kong. The prize shall be awarded annually with effect from the academic year 2010–11.

French Centre for Research on China Award in Modern China Studies

In 2011, the French Centre for Research on China (CEFC) offered to establish an award for the most outstanding student(s) of the School of Modern Languages and Cultures to reward his or her achievements and interest in the study of Modern China. The award shall be given on the basis of academic merit to Bachelor of Arts students studying Modern China Studies at the University. The award shall comprise eight issues of the CEFC's journal *China Perspectives*. Four of the issues will come from the period preceding the award ceremony and four will be from the period after the ceremony to be mailed to the award winner.

French Consulate General Summer Course Travel Grant

In the 2003–04 academic year, the French Consulate General Summer Course Travel Grant was established through the generous donation of \$20,000 for the purpose of supporting students at the University of Hong Kong in language training programmes in France in the summer months. The grants shall be awarded on the basis of academic merit and personal merit to second-year undergraduate students studying the French language at the University. In June 2005, an additional sum of \$45,000 was received.

French Foreign Trade Council Summer Course Travel Grant

In the 2003–04 academic year, the French Foreign Trade Council Summer Course Travel Grant was established through the generous donation of \$22,500 for the purpose of supporting students at the University of Hong Kong in language training programmes in France during the summer months. The grants shall be awarded on the basis of academic merit and personal merit to second-year undergraduate students studying the French language at the University. In September 2005, an additional donation of \$7,500 was received.

George Endacott Prize in History

In 2007, to mark the sixtieth anniversary of the re-establishment of the Department of History after the Second World War, the teachers and former teachers of the Department donated a History prize in memory of George B. Endacott (ob. 1971), Lecturer (1946–57) and Senior Lecturer (1957–62) in History. Mr Endacott was responsible, virtually single-handedly, for the re-establishment of the History Department in 1946 and continued to teach in the Department until he took up an appointment as Secretary of the University Appointments Service in 1962. His main research interest was in the area of Hong Kong history, which he established as a respectable field of scholarship in the 1950s. This prize seeks to perpetuate the memory of a man who did much to re-establish the Department of History as one of the principal teaching and research units in the Faculty of Arts during the 1950s.

Donations to the capital fund of approximately \$25,000 will be made in the five years leading up to the centenary of the Department of History in 2012, together with donations of \$1,000 per annum in the same period for the funding of prizes.

German Consulate General Book Prize

In 2002, the German Consul General agreed to provide a prize for the most outstanding BA III student of the School of Modern Languages and Cultures' German Section to reward his or her achievement and interest in the study of German.

Gloria Yap Prize in Chinese History and Culture (葉濤中國歷史文化獎)

Ms Gloria Yap has kindly made a donation of \$10,000 towards the establishment of a prize to be awarded annually from the academic year 2012–13.

Helen Moore-Williams Music Prize

In 1990, Dr Anne Boyd, the founding head of the Department of Music, donated a sum of \$5,000 for the establishment of a prize in Music in honour of her mother's sister. The prize is to be awarded annually to a BA student with the highest academic results in Music in the First Examination.

Hermès French Language Prize

In the 2000–01 academic year, the Hermès French Language Prize was established through the generous donation of Hermès Greater China Ltd. for the purpose of supporting students of the University of Hong Kong in their language training programme in France in the summer months. One prize of the value of \$7,500 shall be awarded on the basis of academic merit to a second-year undergraduate who is studying the French language.

HKU MACHS Alumni Prize for MA in Chinese Historical Studies

(香港大學中國歷史研究文學碩士課程同學會獎)

The HKU MACHS Alumni Association has kindly made a donation of \$15,000 towards the establishment of a prize to be awarded bi-annually from the academic year 2011–12. The prize of \$3,000 shall be awarded bi-annually to a final-year student with the best results in the MA in Chinese Historical Studies.

Ho Chuk Ping Prizes in Chinese Literature

In 2001, Mr Ho Chuk Ping made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2001–02, to the student with the best results in the course 'CHIN2123 Shi poetry up to the nineteenth century' and the other to the student with the best results in the course 'CHIN2124 Shi poetry: selected writers'.

Ho Fook and Chan Kai Ming Prizes

Two prizes of the value of \$350 each are awarded each year. In 1998, the value of the two prizes was increased to \$700 each.

Ho Pui Hung Prizes in Chinese Prose

In 2001, Dr Lee Kwok Wing and Madame Chan Ka Wai made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2001–02, to the student with the best results in the course 'CHIN2121 Prose up to the nineteenth century' and the other to the student with the best results in the course 'CHIN2122 Prose: selected writers'.

H.T. Ho Prize in Fine Arts

In 1980, Mrs Wendy Ho donated a sum of \$20,000 for the establishment of a prize for award to a student reading fine arts.

Hong Kong Economic Journal Monthly 30th Anniversary Prize in Translation

In 2007, Mr Man Cheuk Fei kindly made a donation of \$25,000 to establish a prize to be awarded annually from the academic year 2008–09 to the student with the best result in the course 'CHIN2313 Language studies for translation II'.

Huey Suen Fat Prize in History

In 1983, the University received a donation of \$10,000 made in accordance with the will of the late Mr Huey Suen Fat, for the establishment of a prize in history.

Hung On To Prize

In 2003, a donation of \$50,000 was made from the Hung On To Memorial Fund to establish a prize of the value of \$1,000 to be awarded annually from the academic year 2002–03 to the student with the best results in the course 'CHIN1207 Traditional Chinese culture'.

Jacques Bogart Prize in French

In the 2000–01 academic year, the Balenciaga Prize in French was established through the generous donation of Balenciaga Hong Kong Ltd. for the purpose of supporting students of the University of Hong Kong in their language training programme in France in the summer months. One prize of the value of \$7,500 shall be awarded on the basis of academic merit to a second-year undergraduate who is studying the French language. In 2002, the prize was re-named as the Jacques Bogart Prize in French to reflect the change of the name of the Company.

James Legge Prize

To commemorate both the University's Golden Jubilee and the publication by the University Press of Dr James Legge's *Chinese Classics*, the James Legge Prize was founded with a fund of \$5,000 donated by the London Missionary Society in 1961.

Jao Yu Tsong Memorial Prize in Music

In 1996, Professor Y.C. Jao donated a sum of \$40,000 to establish a prize for award to a student who has achieved the best overall results in the BA Final Examination Part II.

Joseph C.K. Yeung 'Rising Stars of 21st Century' Award in Translation

In 2006, Mr Joseph Chi Keung Yeung kindly made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2006-07, with one of the prizes for award to the student with the best results in the course 'CHIN2311 Translation criticism I (English-Chinese)' and the other to the student with the best results in the course 'CHIN2312 Translation criticism II (Chinese-English)'.

Joseph Yau Sai Man Memorial Prize in English Literature

In January 2007, Mr Leung Lit On of the Arts Alumni Association offered to endow two prizes in English literature by donating a capital sum of \$100,000 to the University. The prizes are to honour the memory of Joseph Yau Sai Man, a graduate of the University in English Literature (1974) who died in 1998. The award of US\$1,000 shall be made on the basis of academic merit to a graduating student of the Master of Buddhist Studies programme who has the highest average score in the two foundation courses — 'Early Buddhism' and 'Mahayana Buddhism'.

Lai Chi Hsi Prize in Chinese History

In 2001, Mr T.C. Lai made a donation of \$50,000 to establish a prize to be awarded annually from the academic year 2001–02 to a third-year student with the best results in Chinese History.

Lau Sai Yan Prizes in Chinese Language

In 2001, Mr Lau Sai Yan made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2001–02, to the student with the best results in the course 'CHIN2140 Modern Chinese language I' and the other to the student with the best results in the course 'CHIN3140 Modern Chinese language II'.

Lee Kam Woon Prizes in Chinese History

In 2004, Mr Lee Kam Woon kindly made a donation of \$100,000 to establish two prizes of the value of \$1,000 each to be awarded annually from the academic year 2004–05, with one of the prizes for award to the student with the best results in the course 'CHIN1205 Chinese history: a general survey' and the other to the student with the best results in the course 'CHIN1206 An introduction to Chinese thought'.

Lee Kwok Wing Prize in Chinese Fiction and Chan Ka Wai Prize in Chinese Drama

Longman Prizes in Chinese Literature

The Pearson Education Asia Ltd. has kindly made a donation of \$50,000 to establish five prizes to be awarded annually from the academic year 2004–05 to five students with the highest scores in the course 'CHIN1110 Creative writing'.

Ma Meng Prize in Chinese Language

The Professor Ma Meng Memorial Foundation contributed a sum of \$25,000 towards the establishment of a prize to be awarded annually from the academic year 2008–09. The prize shall be of the value of \$1,000.

Professor Ma Meng Prize in Chinese Language

In 2006, Xianggang Putonghua Yanxishe Limited pledged to make a contribution of \$100,000 to be paid over a period of 10 years with an annual instalment of \$10,000 towards the Professor Ma Meng Memorial Foundation for the establishment of four prizes to promote Chinese language learning. Macmillan Prize in English Language and Linguistics

In January 2006, Macmillan, a leading global ELT and academic publisher based in the UK, offered to donate to the University a prize of \$500 in the form of a cash coupon for a Macmillan publication to be redeemed from the University bookstore, for annual award from 2005–06 to 2010–11 to a student in the Department of English who has shown outstanding academic achievements in a given academic year. The prize shall be awarded to a final-year BA student majoring in English Studies.

Macmillan Prize in English Language and Communication

In January 2006, Macmillan, a leading global ELT and academic publisher based in the UK, offered to donate to the University a prize of \$500 in the form of a cash coupon for a Macmillan publication to be redeemed from the University bookstore, for annual award from 2005–06 to 2010–11 to a student in the Department of English who has shown outstanding academic achievements in a given academic year. The prize shall be awarded to a final-year BA student majoring in Language and Communication.

Margaret Ho's Prize in French

In 2008, Mrs Margaret Ho offered a generous donation \$5,000 to the University of Hong Kong towards the establishment of a prize to be awarded annually from the academic year 2008–09.

Philips Prize in Italian

In 2010–11, Philips Electronics Hong Kong Ltd. is offering to establish a prize for further Italian language training in Italy. The value of the prize shall be \$3,500.

Poon Siu Poon Prizes in Chinese Literature

In 2001, the late Mr Poon Siu Poon's family made a donation of \$50,000 to establish two prizes to be awarded annually from the academic year 2001–02, with one of the prizes for award to the student with the best results in the course 'CHIN2125 Ci poetry up to the nineteenth century' and the other to the student with the best results in the course 'CHIN2126 Ci poetry: selected writers'.

Prizes in Translation and Linguistics

In 1975, the University received an anonymous donation for the establishment of two prizes.

Pronunciation Prize

In 2006, Sinolang Education Co. Ltd. offered to establish an award for students studying Japanese, French, German, and Spanish at the University of Hong Kong. The award shall be used for further language training, including the purchase of airline tickets or study materials, payment of tuition fees, etc. The value of the award shall be determined by Sinolang Education Co. Ltd. and may vary from year to year.

R.K.M. Simpson Prize in English

In 1962, a fund of over \$7,000 was raised by friends and former students and colleagues of Professor R. K.M. Simpson, Professor of English from 1921 to 1951 and Emeritus Professor from 1951 to 1969, for the establishment of a prize in his honour.

Professor Robert Lord Memorial Prizes in Comparative Literature and Music

In 2008, Mr Leung Lit On of the Arts Alumni Association offered to endow two prizes in Comparative Literature and Music in memory of Professor Robert Lord, who taught in the Language Centre, by donating a capital sum of \$100,000 to the University of Hong Kong. They shall be awarded to second-year BA students majoring in Comparative Literature and Music who have attained the best overall academic results in a given year. The prizes shall be awarded with effect from the academic year 2008–09.

Sir Robert Kotewall Memorial Prize

The late Dr Bobbie Madeleine Kotewall bequeathed a sum of \$100,000 to the University of Hong Kong to set up an endowment fund, the Sir Robert Kotewall Memorial Fund, which will award prizes to students of the University with effect from the academic year 2009–10.

Mrs Rosie Chen Prize in Phonetics

In June 2007, Mrs Rosie Chen pledged a donation of \$50,000 to establish a prize to be awarded annually from the academic year 2007–08 to the second-year/third-year undergraduate student with the best results in the course 'LING2004 Phonetics'.

In 2007, the prize shall be awarded to a final-year undergraduate who has obtained First Class Honours in the Final Examination for the degree of BSocSc or the degree of BSc in the Statistics programme (specializing in either Statistics or Risk Management), and in the subsequent years to one who is majoring in Statistics or Risk Management who has obtained First Class Honours in the Final Examination for the degree of BSc.

Seven's Prize in Italian

In 2009 the Seven H.K. Limited through the Consulate General of Italy offered to establish a prize to the most outstanding student(s) of the School of Modern Languages and Cultures to reward his or her achievements and interest in the study of Italian. The prize shall be awarded annually from the academic year 2008–09.

Shum Choi Sang Prize in Chinese Studies and Shum Kai Kee Prize in Chinese Studies

The prize shall be awarded with effect from the academic year 2008–09.

The University of Hong Kong Museum Society Museum Studies Prize

Through the generosity of the donor, the University of Hong Kong Museum Society, an annual prize of \$1,500 shall be offered to a student who achieves the best result in any course or courses in the field of Museum Studies offered by the Department of Fine Arts. The prize shall be awarded with effect from the academic year 2008–09.

In 1999, the Australian Society of CPAs established one accounting prize to be awarded annually with effect from the academic year 1999–2000. In 2001, the prize was renamed as the CPA Australia Prize to reflect the change of the name of the society to 'CPA Australia'. In 2010, the prize was further re-named as the CPA Australia Excellence Award.

Grace Wei Huang Memorial Prize

In 1999, the Grace Wei Huang Memorial Fund was established by friends and alumni of HKU in memory of Mrs Grace Wei Huang, and for the promotion of business studies at the University. The prize shall be awarded to a BBA first-year student [i.e. BBA, BBA(Acc&Fin), BBA(IBGM), BBA(Law) or BBA(IS)].

The Hong Kong Institute of Chartered Secretaries Prize in Company Law

In 1990, the Hong Kong Institute of Company Secretaries (renamed as The Hong Kong Institute of Chartered Secretaries with effect from August 2005) established a prize of the value of \$900 for award to a BBA or BBA(Acc&Fin) student who has achieved the best examination results in the paper 'Company law'. In 1997, the donor increased the value of the prize to \$1,200. In 2001, BBA(Law) and BBA(IS) students were also eligible to be considered for this award. In 2004, the value of the prize was revised to \$2,500 with effect from the 2004–05 academic year. In September 2005, the name of the prize was re-named as the Hong Kong Institute of Chartered Secretaries Prize in Company Law and the value of the prize was revised to \$3,000 with effect from the 2005–06 academic year. In November 2009, the prize value was revised to \$1,500 with effect from the academic year 2009–10. BBA(IBGM) students were to be included for award of the prize commencing in the 2011–12 academic year.

Jao Tao Su Prize in Economics

(The same entry can also be found on p. 58, under Faculty of Social Sciences)

Jao Tao Su Prize in Finance

In memory of his late father, Professor Y.C. Jao, Honorary Professor and former Reader in the School of Economics and Finance, made a donation for the establishment of the Prize in 2004 and subsequent donations in 2008 and onwards.

Dr Joe Lu Memorial Prize in Accounting

In memory of Dr Joe Lu, Assistant Professor in the School of Business, his father, Mr Lu Pei De, donated in 2005 a sum of \$29,281 for the establishment of a Dr Joe Lu Memorial Prize in Accounting. The prize shall be awarded annually with effect from the 2005–06 academic year until depletion of the fund.

Peter Willoughby Medal and Memorial Prize in Tax Law

The Peter Willoughby Memorial Fund was established in April 2000 for the purpose of, *inter alia*, awarding a medal and two memorial prizes annually to two students registered for the LLB, BBA(Law), BSocSc(Govt&Laws) or BEng(CivE-Law) at the University.

The Taxation Institute of Hong Kong Prize

In 2005, The Taxation Institute of Hong Kong offered to set up a prize at the University of Hong Kong to give recognition of the academic achievement of the students pursuing the BBA(Acc&Fin) programme at the Faculty of Business and Economics of the University. The Prize, of the value of \$5,000, shall be awarded annually to a full-time Year Two or Year Three BBA(Acc&Fin) undergraduate who has the best results in the course 'Hong Kong taxation', evident upon the most recent examination results.

UMA Prizes

In 1987, the H.K. University Management Alumni Society donated two prizes to two final-year MBA students annually. In 1992, the Society donated three prizes annually to the best graduate of the BBA, the MBA and the FDipM. In 1996, the Society donated four prizes for award to BBA, BBA(Acc&Fin) and MBA students.

W.S. Wong Prize in Accounting

For the promotion of academic interest in accounting, Dr W.S. Wong of W.S. Wong and Company (Public Accountants) has offered to the University one hundred shares Hong Kong and Whampoa Dock Company Limited to establish a prize to be awarded to an undergraduate who has obtained the highest aggregate marks in the Accounting and Finance papers in the BBA(Acc&Fin) Final Examination.

PRIZES TENABLE IN THE FACULTY OF DENTISTRY*A.D. Renson Prize in Oral Health for the Handicapped Patient*

In 1987, to commemorate the 50 years of service to the dental profession (1937–87) by his brother, Dr A.D. Renson, Professor C.E. Renson donated a sum of money for the establishment of a prize to be awarded to fourth-year BDS students.

The Colgate Prize for Community Oral Health

The Colgate Prize shall be awarded annually to a group of BDS students for the best presentation of a community oral health project, during the BDS curriculum, at the Faculty of Dentistry with effect from the academic year 2012–13.

David Atkins Memorial Prize

In 1985, friends of the late David Atkins, Lecturer in the Department of Biochemistry, donated a sum of money to establish a prize in his memory for award to first-year dental students.

Dental 85 Prize in Elective Studies

In 1995, to commemorate the 10th graduation anniversary, the BDS graduates of Class 1985 donated a sum of \$50,000 to establish a prize for award to a final-year dental student who has achieved the best performance in the elective study project.

Dental Update Prize

In 2000, Dental Update Editorial Board established a prize, for an initial period of five years, to be awarded to a student completing the Postgraduate Diploma in General Dental Surgery on the basis of attainment of best overall performance in both coursework and the examination held at the completion of the programme.

Fearnhead Prize

In 1985, on his retirement from the University, and to mark his contribution to the development of the Faculty of Dentistry, friends and colleagues of Professor R.W. Fearnhead donated a sum of money to establish a prize for award to second-year dental students. The prize of the value of \$4,000 shall be awarded to the best performing candidate in the knowledge-based paper of the BDS II Assessment.

Frank White Memorial Prize in Anatomy

In 1997, former friends and colleagues of the late Professor Frank White raised a fund for award of a prize to a BDS II student with good performance in the BDS I and BDS II Assessments on the basis of an essay submitted on the subject of Anatomy at the invitation of the Department of Anatomy. The essay would be set and assessed by a member of the Department of Anatomy.

G-C Dental Prize in Dental Materials Science

In 1990, G-C Dental Industrial Corporation donated the sum of \$1,000 annually for the establishment of a prize to be awarded to a third-year BDS student. In 1997, the value of the prize was increased to \$2,000.

GlaxoSmithKline Postgraduate Prize in Periodontology

In 2008, GlaxoSmithKline (GSK) Hong Kong Limited established a prize to be awarded annually to a final-year student who, having regard to performance in all Periodontology components of the BDS I – V Assessments and Periodontology Key Skills, has the best overall performance in Periodontology. The prize shall be a cash prize of the value of \$5,000.

Ho Fook and Chan Kai Ming Prizes

In 1981, two prizes of the value of \$350 each were established with the agreement of the families of the late Mr Ho Fook and the late Mr Chan Kai Ming. In 1998, the value of the two prizes was increased to \$700 each.

Ho Ping Kwan Prize in Oral Rehabilitation

In 1984, Dr Ho Fook Chuen, Gordon and Dr Ho Fook To donated to the University a sum of \$10,000 for the establishment of a prize in prosthetic dentistry in memory of their late father, Mr Ho Ping Kwan. The prize shall be awarded annually in the form of books or journal subscriptions to the value of the annual income from the donation to the student in the final year of the BDS course who has achieved the best overall standard in preclinical practice of Oral Rehabilitation.

Hong Kong Dental Association Prize

In 1984, the Hong Kong Dental Association established a prize comprising an inscribed plaque and a gift coupon of the value of \$500 to be awarded annually. In 2000, the value of the cash prize was increased to \$5,000.

Hong Kong Endodontic Society Prize in Preclinical Endodontics

In 2000, the Hong Kong Endodontic Society established a prize to be awarded annually to a BDS II student in the form of medal and a cash prize of the value of \$3,000.

Hong Kong Society for Sedation and Anaesthesia in Dentistry Prize

In 2007, the Hong Kong Society for Sedation and Anaesthesia in Dentistry established a prize to be awarded annually to a final-year BDS student on the basis of academic performance in Sedation and Anaesthesia during the course of BDS IV and BDS V.

Hong Kong University Dental Alumni Association Prize in General Dentistry

In 1999, the University of Hong Kong Dental Alumni Association established a prize to be awarded annually to BDS students in the form of a plaque and a cash prize of the value of \$1,000.

Oral-B Prize in Community Oral Health

In 1987, Oral-B Laboratories Pty. Limited established a prize of the value of \$2,000 to be awarded annually to a student group from the Department of Periodontology and Public Health which has completed the best community oral health project, during the fourth year of the BDS curriculum. In 1997, the value of the prize was increased to \$2,500.

Oral-B Prize in Periodontology

In 1987, Oral-B Laboratories Pty. Limited established a prize of the value of \$1,000 to be awarded annually to a final-year BDS student who has achieved the best overall result in the subject Periodontology. In 1997, the value of the prize was increased to \$1,500.

PPDH Board of Governors Prize

In 1984, the then Hon. Lydia Dunn, Chairman of the Board of Governors of the Prince Philip Dental Hospital, donated a sum of \$50,000 for the establishment of a prize to be awarded annually.

The Royal Australasian College of Dental Surgeons (RACDS) Prize

In 2004, the Royal Australasian College of Dental Surgeons established a prize to be awarded annually to a BDS final-year student on the basis of performance in the BDS V Assessment and performance in PBL tutorials during the fifth year of the BDS course.

University of Hong Kong Dental Alumni Association Prize

In 1987, the University of Hong Kong Dental Alumni Association established a prize to be awarded annually to a group of BDS students who has completed, during the fourth year of the BDS curriculum, the community oral health project which makes the greatest contribution to the promotion of oral health or dentistry in Hong Kong.

Dr Wong Min Sam Prize in Paediatric Dentistry and Orthodontics

In 1986, in memory of the late Dr Wong Min Sam, and in order to mark his special contribution and long service to the dental profession in Hong Kong and his particular interest in paediatric dentistry and orthodontics, Dr William Wong Wing Bill and his family donated a sum of money for the establishment of a prize to be awarded to final-year BDS students.

PRIZES TENABLE IN THE FACULTY OF EDUCATION

Education Faculty Service Prize for Bachelor of Education in Language Education/Liberal Studies

In 2012, the Lions Club of Metropolitan Hong Kong generously pledged a donation to the Faculty of Education for the establishment of a prize.

The Equilibrium Cultural Education Foundation Award

In 2001, the Equilibrium Cultural Education Foundation established the Equilibrium Cultural Education Foundation Award in the Faculty of Education from 2001–02 to be awarded to a BEd(LangEd) final-year student.

Dr Jon Maxwell Undergraduate Dissertation Prize

In 2009 Dr Jon Maxwell passed away suddenly. In remembrance of Dr Maxwell's many contributions to the academic life of the Institute of Human Performance, a prize is to be awarded annually from the academic year 2009–10 to a final-year student pursuing a major or minor in exercise science who is deemed by the Board of Examiners for the degree of BSc(Exercise&Health) to have completed the best dissertation. The prize shall be in the form of a book voucher at the value of \$1,500.

Longman Prize in Education

In 1986, the Longman Group (Far East) Ltd. donated a sum of \$3,000 for the establishment of a prize to be awarded annually for three years from 1986–87. In 1993, the donor extended the prize for three years. The value of the prize was subsequently increased to \$4,500 for 1993–94 and 1994–95.

Norman Chui Prizes

In May 2004, Mr Norman Chui offered to pledge a sum of \$6,000 per year for a period of 10 years initially for the award of two prizes to graduates of the Faculty of Education with effect from the 2004–05 academic year.

Rowell Prizes in Education

A sum of \$9,000 was donated to the University in 1952 for the foundation of one or more scholarships in education. Revised regulations now provide for the awards to be made in the form of prizes, of the value not less than \$200 each.

Tao Ping-kee Prizes in Science Education

In 2004, alumni, friends and family of the late Dr Louis Tao Ping-kee donated more than \$83,000 to set up prizes for excellence in science education in the Faculty of Education in memory of Dr Tao, former Associate Professor of the Faculty.

True Light Middle School of Hong Kong Prizes in Education

In 1986, the True Light Middle School of Hong Kong donated \$20,000 to the University for the establishment of two prizes to be awarded annually, and in 1989 donated a further \$10,000 for the sponsorship of this prize.

PRIZES TENABLE IN THE FACULTY OF ENGINEERING

BUDA Group Prize

In 2005, BUDA agreed to donate, starting from 2005, an amount of \$10,000 annually, to the Department of Mechanical Engineering of the University of Hong Kong for the establishment of two BUDA Group Prizes. The two prizes shall be of the value of \$5,000 each.

CLP Power Project Prizes in Electrical Energy

In 1995, the China Light & Power Co. Ltd. donated until 2000–01 two project prizes of the value of \$2,000 each to students following the Electrical Energy Systems Engineering curriculum. In 1999, the name of the prizes had been changed to CLP Power Project Prizes in Electrical Energy as a result of the change in the name of the company.

C.K. Leung Award for Academic Achievements

C.L. Tse Prize in Civil Engineering

In 1995, Mr C.L. Tse of China Translation and Printing Service Limited donated a sum of \$20,000 for the establishment of a prize for award to Civil Engineering students.

The Chartered Institution of Building Services Engineers Prize

The Chartered Institution of Building Services Engineers Book Prize

The Chartered Institution of Building Services Engineers Student Project Prize

In 2002, the Chartered Institution of Building Services Engineers (Hong Kong Branch) agreed to donate a prize to the University of Hong Kong with effect from the academic year 2002–03. In October 2005, the Institution increased the prize value from \$4,000 to \$5,000 with effect from 2004–05 and offered a new Book Prize of \$1,000 for award from the academic year 2005–06. In February 2008, an additional CIBSE Student Project Prize was added for the award from the academic year 2007–08. The first two prizes shall be awarded on the basis of academic merit to two separate full-time students in any year of study taking an undergraduate degree programme in building services engineering or a relevant degree programme with a major in building services engineering. The third prize shall be granted on the basis of the BBSE3005 interdisciplinary building services design project Phase I result. The value of the first prize is \$5,000, the value of the book prize is \$1,000 and the value of the project prize is \$2,000.

Mrs Cheung Chu Yuk Bau Prizes in Civil Engineering

In 2010, the family and friends of the late Mrs Cheung Chu Yuk Bau, beloved wife of Professor Y.K. Cheung, donated a sum of \$250,000 to the University. These monies will be used for the establishment of three prizes in memory of Mrs Cheung, who passed away on October 22, 2010. The three prizes will be made to students in the Department of Civil Engineering annually from the academic year 2011–12.

Chow Che King Prize

The year 1955 marked the recognition of the BSc(Eng) degree by the Institution of Civil Engineers, UK and the Introduction of the 'Honours' system after substantial upgrading of the syllabus and much hard work of all those concerned.

To commemorate his graduation from the Department of Civil Engineering of the University of Hong Kong for 50 years, Ir Chow Che King donated a sum of \$20,000 in 2005 for the establishment of a prize to be awarded annually with effect from 2004–05.

Civil Engineering Project Prize

In 1982, Dr G. Sved, who had been temporary lecturer in the University in 1978, 1979 and 1982, donated \$800 for the establishment of a prize to be awarded annually to the student attaining the best result in the final year project in Civil and Structural Engineering for the degree of BEng. In 1984, a donation of \$600 was added to the funds remaining from the 1982 donation, and the prize was supplemented in 1989 by a further donation of \$750. In 1993, Mr J. MacArthur, Director of Ove Arups & Partners, donated \$1,500 for the prize to continue to be awarded to the students annually for four years starting from the academic year 1993–94. In 1997 and 1998, Mr Dennis Rockey made a further donation of \$2,000 each year for the award.

Dick Feast Memorial Prize

In September 2012, the family of the late Mr Richard John Feast decided to donate a sum of \$50,000 to the University, for the purpose of establishing the Dick Feast Memorial Prize, in memory of Mr Feast who had been involved in the MSc(Eng) teaching of the Department of Civil Engineering for many years.

Edward Keller Achievement Award in Civil Engineering

In 1978, the Honor Industrial Development Company Limited of Hong Kong donated a sum of \$10,000 for the establishment of the Wild Heerbrugg Achievement Award in Civil and Structural Engineering. In 1991, the Honor Industrial Development Co. Ltd. became a division of the Edward Keller Ltd. and the prize was retitled the Edward Keller Achievement Award in Civil Engineering which will be awarded annually.

Environmental Engineering Prize

In 1992, the Oriental Environmental Services Limited of Hong Kong donated a sum of \$20,000 for the establishment of a prize in the Department of Civil Engineering.

Fong's Scholarship in Mechanical Engineering and Fong's Project Prize in Mechanical Engineering

In 2003, Fong's National Engineering Co. Ltd. donated, starting from 2003–04, an amount of \$100,000 annually to the Department of Mechanical Engineering for the establishment of six scholarships and four project prizes (totalling \$80,000), and sponsorship of engineering design projects (totalling \$20,000).

Gammon Construction Limited Prizes in Building Technology and Civil Engineering

The HKMHDMA Prize

In 2004, The Hong Kong Medical and Healthcare Device Manufacturers Association Limited (HKMHDMA) donated the following Prize for the Medical Engineering students of the University of Hong Kong:

The HKMHDMA Prize for the Best Student in Level I, of the value of \$500, for award to a BEng in Medical Engineering student who has achieved the best academic result in his/her first year of study.

The HKMHDMA Prize for the Best Student in Level II, of the value of \$500, for award to a BEng in Medical Engineering student who has achieved the best academic result in his/her second year of study.

The HKMHDMA Prize for the Best Graduate in Medical Engineering, of the value of \$2,000, for award to a BEng in Medical Engineering graduate who has achieved the best academic result in his/her final year of study.

HKU Engineering Alumni Association Prize

To commemorate the 75th Anniversary of the Faculty of Engineering, the HKU Engineering Alumni Association in January 1988 donated to the University the sum of \$15,000 for the establishment of a prize. The Association has also indicated that it will increase the value of the donation to enable the prize to be awarded annually in future years.

H.K. Cheng Prize in Civil Engineering

In 1982, Mr H.K. Cheng donated \$10,000 for the establishment of a prize to be awarded annually.

Himont Prize in Plastics Technology

In 1989, Himont (Far East) Limited donated a sum of \$20,000 for the establishment of a prize to be awarded annually.

Ho Fook and Chan Kai Ming Prizes

Four prizes of the value of \$350 each are awarded each year. In 1998, the value of the four prizes was increased to \$700 each.

Ho Iu Kwong Prize in Civil Engineering

In 1978, Mr Ho Iu Kwong of Hong Kong donated a sum of \$10,000 for the establishment of a prize to be awarded annually.

The Hongkong Electric Co. Ltd. Energy Systems Prizes (港燈能源系統獎)

In 1992, the Hongkong Electric Co. Ltd. provided a total of three awards of \$5,000 each for the highest-ranking students of the first, second and third years in the Energy Systems Engineering stream of the Department of Mechanical Engineering from 1993–94.

The Hongkong Electric Co. Ltd. Project Prize in Electrical Energy (港燈電能專題獎)

In 1995, the Hongkong Electric Co. Ltd. donated a project prize of the value of \$2,000 to students following the Electrical Energy Systems Engineering curriculum. From the academic year 2008–09, the Prize of the value of \$2,000 shall be awarded to a final year student in the Department of Electrical and Electronic Engineering following the Electrical Energy Systems Engineering curriculum.

Hong Kong Government Industry Department Prize in CAD/CAM Technology

In 1992, arising from a co-ordinated CAD/CAM project between the University of Hong Kong and the Hong Kong Government, a sum of \$60,000 was donated by the Industry Department (Hong Kong Government) to the University for the establishment of two prizes to promote studies in CAD/CAM technology.

Hong Kong Institution of Engineers Prizes

In 1976, the Hong Kong Institution of Engineers donated a sum of \$800 each year for the establishment of eight prizes. In 1985, the Institution increased the donation to \$1,600 each year. In 1997, the Institution decided to offer five prizes of the value of \$500 each.

Hong Kong Joint Branch of the Royal Institution of Naval Architects and the Institute of Marine Engineers Prize

In 1981, the Hong Kong Joint Branch of the Royal Institution of Naval Architects and the Institute of Marine Engineers donated a sum of not less than \$200 a year for an indefinite period for the award of a prize. The value of the prize is currently \$1,000.

Industrial and Manufacturing Systems Engineering Project Prizes

In 1978, Dr J.B. Peacock, who taught at the University during 1974–78, donated \$500 for a prize of \$100 to be awarded annually for five years. In 1981, Professor W.A. Reynolds donated \$5,000 to add to the balance of Dr Peacock's donation to establish a total of three prizes.

Institute of Electrical and Electronics Engineers (Hong Kong Section) Prize

In 1980, the Institute of Electrical and Electronics Engineers (Hong Kong Section) donated a prize to be awarded annually until further notice. In September 1998, the donor increased the value of the prize from \$1,000 to \$1,500 with effect from the 1998–99 academic year.

Leung Wai Sun Prize in Electrical and Electronic Engineering

In 1994, friends and colleagues of Professor W.S. Leung, the second post-war Professor of Electrical Engineering, donated cash of over \$1 million and two annual international return air tickets to the University to establish the Leung Wai Sun Fellowships to mark his retirement. To boost the advancement of education in Electrical and Electronic Engineering in Hong Kong, part of the annual income generated by the capital sum will be used for the award of the Leung Wai Sun Prize in Electrical and Electronic Engineering starting from the academic year 2010–11. One prize shall be awarded annually to each of the top students of undergraduate programmes who has achieved the best overall results in the third year and final year of study in the Department of Electrical and Electronic Engineering.

Li Pai-lin Prize in Civil Engineering

In 1986, Mr Li Pai-lin donated a sum of \$5,000 for the establishment of a prize to be awarded annually.

MWH/Peter HK Chan Memorial Award

In November 2001, MWH Hong Kong Ltd. agreed to donate an annual award to the University with effect from the academic year 2001–02. The award of the value of \$20,000 shall be made to the top graduate of the degree of BEng in Civil Engineering (Environmental Engineering).

Ma Tze Sau Prize in Mechanical Engineering

In 1977, in memory of his father Ma Tze Sau, Mr Ma Tin Chak donated a sum of \$10,000 to establish a prize for award annually.

Madam Ng Man Ching Prize

In 2004, Professor Y.L. Choi established a prize to be awarded annually with effect from 2004–05. The prize shall be awarded to a second-year MSc(Eng) student of the Department of Civil Engineering who has achieved the highest average mark in four core courses in Environmental Engineering or Transportation Engineering in his/her first-year of studies.

Norman W.M. Ko PhD Prize

In 2003, Professor Norman W.M. Ko donated \$200,000 to the University to set up a prize to be awarded from the academic year 2004–05. The prize shall be awarded every two years to a student registered for the degree of PhD in the Faculty of Engineering.

Pegasus Automation Prize in Industrial and Manufacturing Systems Engineering

For promoting education in low-cost automation in Hong Kong, Pegasus Enterprises (I/E) Limited in 1977 donated a sum of \$10,000 to establish a prize for award annually.

Peter Willoughby Medal and Memorial Prize in Tax Law

(The same entry can also be found on p. 20, under Faculty of Business and Economics)

S.Y. King Prize in Electrical and Electronic Engineering

In 1981, friends and colleagues made a donation of \$15,000 to the University for the establishment of an S.Y. King Prize to mark the retirement of Professor S.Y. King, first post-war Professor of Electrical Engineering.

Tai Tung-Ngok Prize in Civil Engineering

In 1978, Mr Tai Tung-Ngok of Hong Kong donated a sum of \$10,000 for the establishment of a prize to be awarded annually.

Walter Brown Memorial Prizes in Mathematics

(The same entry can also be found on p. 55, under Faculty of Science)

Williamson Prize

This prize, of the value of \$350, is awarded annually to the graduating candidate in engineering who has the best record as an undergraduate. In 1998, the value of the prize was increased to \$700.

Wing Lung Bank Ltd. Prize in Civil Engineering

In 1976, the Wing Lung Bank Ltd. donated a sum of \$10,000 to establish a prize for award annually.

Wong Fan Prize in Electrical and Electronic Engineering

In 1977, in memory of his father, Wong Fan, Mr Wong Ping Kuen donated a sum of \$10,000 to establish a prize for award annually.

PRIZES TENABLE IN THE FACULTY OF LAW*APAA Prize in Issues in Intellectual Property Law or in Copyright Law*

In 1986, the Asian Patent Attorneys Association donated until further notice \$1,000 per annum to the University for the establishment of a prize. In 1996, the value of the prize was increased to \$3,000.

Advocacy Institute of Hong Kong Prize in Advocacy

In 1996, the Advocacy Institute of Hong Kong donated a prize of the value of \$4,000 for award to a PCLL student who has achieved the best performance in the Advocacy course.

Allen & Overy Prize in Corporate and Financial Law

In 2000, Allen & Overy, an international law firm, donated two annual academic prizes to be awarded to the top two student graduates in Master of Laws in Corporate and Financial Law [LLM(CFL)] curriculum. The prizes shall be of the value of \$8,000 each.

Anna Wu Prize in Human Rights

In 2001, Ms Anna Wu agreed to donate a sum of \$4,000 annually for an initial period of five years, with effect from the academic year 1999–2000, to the Centre for Comparative and Public Law to be awarded to a student registered in the University of Hong Kong for the degree of Master of Laws in Human Rights [LLM(HR)]. In 2007, Ms Wu donated \$21,100 together with the remaining balance to award the prize for another eight years from 2007 to 2014.

Baker & McKenzie Leung Cheuk Yan Prize in PRC Securities

In 2011, Baker & McKenzie donated a sum of \$50,000 to the Faculty of Law for the establishment of a subject prize to honour its partner, Mr Leung Cheuk Yan, for his contribution to the development of the securities market in China and Baker & McKenzie's practice in this market since the early 1990s. The prize of \$3,000 shall be awarded to a student registered in the Master of Laws programmes, who has achieved the best performance in the course 'Company law and securities regulation in the People's Republic of China'.

*Baker & McKenzie Prize in Business Associations
Baker & McKenzie Prize in Company Law*

In 1979, Baker & McKenzie, Solicitors and Notaries, donated two prizes of \$1,000 each to the University to be awarded in the form of legal textbooks. In 1992, the donor increased the value of the prizes to \$3,000. With effect from 1995–96, the donor increased the value of the Baker & McKenzie Postgraduate Prize to \$5,000, and agreed that the former Baker & McKenzie Prize for Agency and Business Associations be separated into the Baker & McKenzie Prize in Business Association and the Baker & McKenzie Prize in Law Agency, at the value of \$3,000 each. In 2001–02, the Baker & McKenzie Prize in Law Agency was re-named as the Baker & McKenzie Prize in Company Law, whilst the Postgraduate Prize would no longer be offered.

Belinda S.Y. Wong Leung Prize for Constitutional and Administrative Law I and II

In 1998, Ms Belinda Wong, graduate of the Faculty of Law, donated a prize of the value of \$5,000 annually to be awarded to a LLB student who has achieved the highest mark in the course 'Constitutional and Administrative Law I and II'.

Bernard Downey Book Prizes

In 1980, to commemorate his period at the University from 1969–80, His Honour Judge Downey, District Judge of Hong Kong, donated to the University funds for the award of two prizes.

Blake Dawson Waldron Prize in Law

In 1989, Blake Dawson Waldron, Solicitors of Sydney, NSW, provided a prize of \$2,000 to the candidate achieving the best performance in the LLM course 'Intellectual property law in China: a comparative perspective'.

Bloomsbury Book Prize in Civil and Criminal Litigation

In 1993, Bloomsbury Books Limited donated \$3,500 each year for the award of a book prize in the 'Civil and criminal litigation' of the PCLL Examination.

Bloomsbury Book Prize in Law

In 1986, Bloomsbury Books Limited offered to donate \$15,000 each year for the award of a book prize in the PCLL curriculum. In early 2004, the donor indicated that the donation would be reduced to \$10,000 with effect from the 2003–04 academic year due to budgetary constraints.

Bloomsbury Books Prize in Law and Society I and II

In 1991, Bloomsbury Books Limited provided an annual prize of the value of \$2,000 for a LLB student who has achieved the best performance in the course 'Law and society I and II'.

Boase Cohen & Collins Prize in Accounts and Financial Management

In 1989, Boase, Cohen & Collins solicitors in Hong Kong, donated an annual book prize to the candidate who has achieved the highest standard in the PCLL course 'Accounts and financial management'. In 1997, the value of the prize was increased to \$3,000. In 2008, the donor agreed to increase the value of the prize to \$4,500.

Brian McElney Medal in Law

In 1974, Mr Brian S. McElney donated a sum of money to the University for the establishment of a prize in law to be awarded in the form of a gold medal.

C.H. Leong Prize in Medico-Legal Issues

In 1996, Dr C.H. Leong donated an annual prize of the value of \$3,000 for award to the student who has achieved the highest standard in the course 'Medico-legal issues'.

Cathay Pacific Award in Aviation and Travel Law

In 1987, Cathay Pacific Airways Limited provided an award annually for a student registered for the LLM degree who has achieved the best performance in the coursework and examinations for the LLM course in either 'Aviation law' or 'International travel law'.

The Conyers Dill & Pearman Prize in Commercial Law

In 2010, Conyers Dill & Pearman offered to donate until further notice US\$5,000 per annum to the University for the establishment of a prize. The prize shall be awarded to a local graduating student registered in the Master of Laws in Corporate and Financial Law programme, who has achieved the best overall performance in the programme. The prize shall be of the value of US\$5,000.

Daniel R. Fung, S.C. Prize in the Hong Kong Basic Law

In 1991, Daniel R. Fung, Q.C. provided a prize of \$1,800 annually for a LLB student who has achieved the best performance in the course 'Human rights law'. In 1997, the value of the prize was increased to \$3,000. In 1999, Daniel R. Fung, Q.C. Prize in Human Rights Law, a former prize donated by Mr Daniel Fung, S.C. was re-named as the Daniel R. Fung, S.C. Prize in the Hong Kong Basic Law.

David Ling Prize

In 1985, Mr David Ling of Hong Kong extended the donation of a prize originally established in 1975 for a further period of ten academic years, and increased the value of the prize from \$1,000 to \$1,500. In 1996, the value of the prize was increased to \$3,000.

Davis Polk & Wardwell Prize

Davis Polk & Wardwell agreed to set up a prize for students registered on the Juris Doctor programme organized by the Faculty of Law.

Deacons Prize in Law

In 1986, the Partners of Deacons donated \$15,000 for the establishment of a prize. In 1997, the donor increased the value of the prize to \$2,500. The value of the prize was revised to \$3,000 in 1998, subject to review in 2001.

Denton Hall Prize in Banking Law

In 1995, Dental Hall donated a prize of the value of \$5,000 for award to an LLB student who has achieved the best result in the course 'Banking law'.

Denton Wilde Sapte Prize in Banking Law

In 1995, Denton Hall donated until further notice \$5,000 per annum to the University for the establishment of a prize. In July 2000, the title of the prize was changed to Denton Wilde Sapte Prize in Banking Law to reflect the change in the name of the firm.

Eric Au Prize in the Use of Chinese in Law

In 1993, the Eric Au Memorial Fund Committee endowed a prize in the use of Chinese in law in memory of Mr Eric Au. The prize shall be awarded annually to a LLB student who has achieved the best result in the course 'The use of Chinese in law'.

F. Zimmern & Co. Prize in Legal System

In 2000, F. Zimmern & Co., a local law firm, donated a prize of the value of \$3,000 for award annually to a student registered for the degree of Bachelor of Laws (LLB). The prize shall be awarded to the student who has achieved the highest mark or grade in the examination in the course 'The legal system'. In 2007, the donor agreed to award the prize to students registered for LLB, BBA(Law), BSocSc (Govt&Laws) or BEng(CivE-Law).

Freshfields Prize in Commercial Drafting

In 1988, the Hong Kong law firm Freshfields donated an annual sum of \$1,500 for the establishment of a prize. In 1997, the value of the prize was increased to \$3,000.

Freshfields Prize in Legal Skills

In 1991, the Hong Kong law firm Freshfields provided an annual prize of the value of \$2,000 for a LLB student who has achieved the best performance in the course 'Legal research and writing'. In 1997, the value of the prize was increased to \$3,000. In 1998, Freshfields Prize in Legal Research and Writing was re-named as the Freshfields Prize in Legal Skills to reflect the change in the course title 'Legal research and writing' to 'Legal skills' as a result of the curriculum reform. In December 2003, the donor has kindly agreed that the value of the prize be further increased to \$6,000.

Betty Ho Prize in Law, Gallant Ho Prize in Law and Gallant Ho Gold Prize in Law

In 2012, in remembrance of the late Ms Betty Ho, Gallant Ho Charities & Public Well-Being Services (HK., PRC) Ltd agreed to donate a sum of \$650,000 to establish ten prizes for award to students of the Faculty of Law from 2012–13.

Gallant Y.T. Ho Prize in Introduction to PRC Law

In 1991, Gallant Y.T. Ho & Co., Solicitors, in Hong Kong, donated an annual prize of \$3,000 to the University to be awarded until further notice to a student who has obtained the highest mark in the LLB course 'Introduction to the law of the People's Republic of China'. In 1997, the value of the prize was increased to \$5,000. In 2000, the Gallant Y.T. Ho Prize in Law was re-named as the Gallant Y.T. Ho Prize in Introduction to PRC Law and the value of the prize was increased to \$10,000.

Haldanes Prize in Criminal Litigation

In 1988, Haldane, Midgley and Booth provided a prize, in the form of a book voucher of the value of \$3,000, to the student who has achieved the best performance in 'Criminal litigation' as part of the PCLL curriculum. In 1997, the value of the prize was increased to \$6,000. In 1998, the title of the prize was changed to Haldanes Prize in Criminal Litigation to reflect the change in the name of the firm.

Hastings Prize in Commercial Law

In November 2005, Hastings & Company agreed to donate an annual prize of \$5,000 to the University for award with effect from the academic year 2005–06 to students reading the degree of Bachelor of Laws and the double degree in law programmes on the subject of Commercial Law.

Helen A. Lo Prize in Principles of Family Law

In 1987, the Hong Kong Federation of Women Lawyers donated until further notice \$2,000 per annum to the University for the establishment of a prize to be awarded to a third-year LLB student who has achieved the best result in the course 'Family law'. In 2000, the prize was re-named as the Helen A. Lo Prize in Principles of Family Law, and the value of the prize was increased to \$3,000.

HKITMP Prize in Intellectual Property Law

In 2009, the Hong Kong Institute of Trade Mark Practitioner offered to donate until further notice \$5,000 per annum to the University for the establishment of a prize.

The HKU Dean's Prize

In 2010, Professor Johannes Chan, SC(Hon), Dean of Law agreed to establish a prize with a one-off donation of \$50,000 for award to Juris Doctor (JD) students who have achieved the best performance in the course 'Legal system'.

The HKU JD Prizes

In 2010, the Faculty of Law agreed to establish nine prizes of the value of \$10,000 each, with its own resources, for award to its first batch of Juris Doctor (JD) students who have achieved the best performance in their nine core courses.

The HKU JD Prize for Overall Excellence: Year 1

In 2010, the Faculty of Law agreed to establish a prize of the value of \$10,000, with its own resources, to be awarded to a Juris Doctor (JD) student who has achieved the best overall performance in the first year of study.

The HKU JD Prize for Overall Excellence: Year 2

In 2011, the Faculty of Law agreed to establish a prize of the value of \$10,000 with its own resources, to be awarded from the academic year 2010–11 to a Juris Doctor (JD) student who has achieved the best overall performance in the first year of study.

Ho Fook and Chan Kai Ming Prizes

Two prizes of the value of \$350 each are awarded each year. In 1998, the value of the two prizes was increased to \$700 each.

Holman Fenwick & Willan Law Prize in Law of Contract I and II and Law of Tort I and II

In December 2000, Holman Fenwick & Willan, an international law firm, donated an annual academic prize to be awarded to a student registered in the University of Hong Kong for the degree of Bachelor of Laws (LLB). The prize shall be awarded to the first-year LLB student proceeding to the second year of study who has obtained the highest aggregate final marks in the examinations in the two courses 'Law of Contract I and II' and 'Law of Tort I and II'.

The Hong Kong Conveyancing & Property Law Association Ltd. Prize in Property Transactions

In 2005, the Hong Kong Conveyancing & Property Law Association Ltd. agreed to provide an annual prize of \$3,500 to the University of Hong Kong to award to a student of outstanding performance in conveyancing.

Hong Kong Maritime Industry Prize

In 2010, The Institute of Seatransport agreed to establish a prize with a one-off donation of \$3,000 to students registered for the course 'Carriage of Goods by Sea' in the academic year 2009–10.

Hong Kong Trustees Association Prize in Equity and Trusts

In 2006, the Hong Kong Trustees Association agreed to donate two annual prizes each of \$5,000 to the University of Hong Kong to award students of outstanding performance in the subjects of Equity and Trusts I and II.

Hong Kong Society of Clinical Chemistry Book Prize

In 2011, the Hong Kong Society of Clinical Chemistry agreed to donate an annual sum for the establishment of the Hong Kong Society of Clinical Chemistry Book Prize. The prize of \$2,000 shall be awarded to a third-year MBBS student who has achieved the most outstanding performance in the viva voce.

IFA Prize in Taxation on Income

In 1995, the International Fiscal Association (IFA) donated a prize of the value of \$2,000 for award to the student who has achieved the best result in the course 'Revenue law'. In 1996, the value of the prize was increased to \$3,000. The prize shall be awarded each year unless otherwise informed by the donor. In October 2003, the donor has kindly agreed to award the prize to LLB students following the deletion of the course 'Revenue' from the syllabus for the PCLL and the addition of the course 'Principles of Hong Kong taxation on income' to the syllabus for the LLB as part of the curriculum reform of PCLL. In 2007, the donor agreed to award the prize to students registered for LLB, BBA(Law), BSocSc(Govt&Laws) or BEng(CivE-Law).

The Institute of Seatrtransport Prize in Carriage of Goods by Sea

In 2009, The Institute of Seatrtransport agreed to donate two prizes of the value of \$4,000 each to be awarded annually to students registered for the course 'Carriage of Goods by Sea' from the academic year 2009–10.

JAC Hui Bon Hoa Prize in Commercial and Corporate Transactions I

During 2006–08, Mr Stephane Hui Bon Hoa donated a total sum of \$2.5 million to establish the JAC Hui Bon Hoa Fund for supporting a variety of academic developments in the Department of Professional Legal Education at the University of Hong Kong. The Management Committee of the Fund agreed to set up the JAC Hui Bon Hoa Prize in Commercial and Corporate Transactions I to award PCLL students of outstanding performance in the course of 'Commercial and corporate transactions'.

JAC Hui Bon Hoa Prize in Commercial and Corporate Transactions II

During 2006–08, Mr Stephane Hui Bon Hoa donated a total sum of \$2.5 million to establish the JAC Hui Bon Hoa Fund for supporting a variety of academic developments in the Department of Professional Legal Education at the University of Hong Kong. In August 2008, the donor also agreed to set up the JAC Hui Bon Hoa Prize in Commercial and Corporate Transactions II to award PCLL students of outstanding performance in the course of 'Commercial and corporate transactions'.

JAC Hui Bon Hoa Prize in Wills, Trusts and Estate Planning

During 2006–2008, Mr Stephane Hui Bon Hoa donated a total sum of \$2,500,500 to establish the JAC Hui Bon Hoa Fund for supporting a variety of academic developments in the Department of Professional Legal Education. In September 2012, the donor also agreed to set up the JAC Hui Bon Hoa Prize in Wills, Trusts and Estate Planning to award PCLL students of outstanding performance in the course 'Wills, trusts and estate planning'.

Jerome Chan Memorial Prize for the Law of Evidence

The Jerome Chan Memorial Fund was established in April 2000 for the purpose of, *inter alia*, awarding a prize annually to a student registered for a law degree at the University of Hong Kong. The prize of the value of \$2,000 shall be awarded to the student who has achieved the highest mark in the course 'Fundamentals of evidence and trial procedure'.

Jerome Chan Prize for PCLL Students

In 1996, Mr Justice Jerome Chan donated a prize of the value of \$1,000 to be awarded annually for a period of seven years to a PCLL student who has obtained a distinction in the PCLL overall and who has not been awarded any other prizes. In 1998, Mrs G.Y.K. Tang continued the prize and increased the value to \$2,000. Mr Jeremy Chan, son of the late Mr Justice Jerome Chan, has been assisting in teaching PCLL courses in the Department of Professional Legal Education. In 2007, Mr Jeremy Chan agreed to donate his salary for teaching in the academic year 2006–07 towards the prize until its depletion and revise the amount of the award to \$3,000.

The John Griffiths Prize in Advocacy

In 1990, Peter Po Fun Chan & Company donated the sum of \$20,000 to the University to establish a prize to be awarded annually to a PCLL student.

JSM Prize in Law of Tort I and II

In 1991 Johnson Stokes & Master, which was renamed as 'JSM' from January 2008, agreed to provide a prize annually for a student registered for the degree of LLB or BBA(Law) or BSocSc(Govt&Laws) or BEng(CivE-Law) whom the Board of Examiners in Laws considers has achieved the best performance in the course 'Law of tort I and II' as part of the LLB curriculum.

Kenny Wong and Alice Lee – Sweet & Maxwell Prize in Intellectual Property Law

In 2012, Sweet & Maxwell, as per the publishing agreement for *Intellectual Property Law and Practice*, established an annual prize.

Law Society of Hong Kong/Bloomsbury Books Prizes

In 2000, Law Society of Hong Kong and Bloomsbury Books Ltd. jointly agreed to provide a prize annually for students registered for the Postgraduate Certificate in Laws (PCLL) for the purpose of assisting them in purchasing the required law textbooks for their PCLL study. Each prize shall consist of book tokens of the value of \$6,000.

Law Society of Hong Kong Prize in Professional Practice

In 1989, the Law Society of Hong Kong provided an annual book prize to the candidate who has achieved the highest standard in the PCLL course 'Professional practice'. In 1995, the value of the book prize was increased to \$4,000. In September 2001, the donor kindly agreed to increase the value of the prize to \$6,000 with effect from the academic year 2001–02.

LexisNexis Book Prize for Legal Research Skills

In 2011, LexisNexis agreed to provide an annual prize for three students registered for the degree of LLB or other undergraduate degrees organized by the Faculty of Law.

*The Linklaters Prize for Overall Excellence in Law: Year I and
The Linklaters Prize for Overall Excellence in Law: Year II*

In 2001, Linklaters agreed to donate two prizes annually for award to the best student in each of the first and second years of the LLB curriculum, in recognition of their outstanding academic performance.

Linklaters Prize in Equity and Introduction to Trusts I and II

In 1989, Linklaters & Paines provided a prize annually for the best performance in the course 'Law of trusts' in the LLB curriculum. In 1999, the name of the prize had been changed to Linklaters Prize in Trusts as a result of the change in the name of the firm. In 2001, the donor expressed the wish for the prize to be awarded to second-year LLB students, and has agreed to change the subject of award to 'Equity and introduction to trusts'.

Linklaters Prize in Law of Contract I and II

In 1990, Linklaters & Paines provided a prize annually for award to the student achieving the best performance in the course 'Law of contract' as part of the LLB degree curriculum. In 1998, Linklaters & Paines Prize in Law of Contract was renamed as the Linklaters & Paines Prize in Law of Contract I and II to reflect the change in the course title 'Law of contract' to 'Law of contract I and II' as a result of the curriculum reform. In 1999, the name of the prize had been changed to 'Linklaters Prize in Law of Contract I and II' as a result of the change in the name of the firm.

The Listed Companies Elective Prize

In 2012, Ms Kitty Wong donated a sum of \$20,000 to establish a book prize for award from the academic year 2011–12 to a Postgraduate Certificate in Laws student who has achieved the best performance in the elective course 'Listed companies'.

Ludlows Prize for Trial Advocacy

To encourage outstanding students to join the Bar or to become solicitor advocates, Ludlows Legal Regalia & Tailors offered in 2007 to donate until further notice annually to the University for the establishment of a prize to students registered for full-time or Year Two part-time Postgraduate Certificate in Laws.

Masons Prize in Alternative Dispute Resolution

In November 2000, Masons, an international firm, agreed to donate a prize of the value of \$5,000 as an annual award to a student registered in the University of Hong Kong for the degree of Bachelor of Laws (LLB) who has achieved the highest mark and/or grade in the examination in the course 'Alternative dispute resolution' in the LLB curriculum.

Masons Prize in Information Technology Law

In October 2000, Masons, an international law firm, donated a prize of the value of \$5,000 as an annual award to a student registered in the University of Hong Kong for the degree of Bachelor of Laws (LLB) who has achieved the highest mark or grade in the examination in the course 'Information technology law'.

Maxwell Law Prize

In 1985, Sweet and Maxwell Limited increased the value of a prize, originally donated in 1982, from £75 to £100, to be awarded to a student reading the PCLL. In October 2001, the value of the prize was further increased to £150.

The Minvie Leung Prize for Property Litigation

In January 2010, Joseph Li & Co agreed to provide an annual book prize of \$5,000 to a student registered for the Postgraduate Certificate in Laws (PCLL) at the University of Hong Kong. The prize is established in memory of the late Ms Minvie Leung to honour her contribution to Hong Kong's legal community.

Ng Choy/Francis Mooting Prize

In 1987, members of the local community, on the proposal of Mr Walter Greenwood, endowed a prize in memory of Ng Choy, the first Chinese barrister admitted to practice in Hong Kong, to be awarded annually to a LLB student who has achieved the highest standard in the moot court competition within the LLB curriculum.

Norton Rose Prize in competition Law

In March 2008, Norton Rose agreed to donate a prize of the value of \$6,000 to be awarded annually with effect from the academic year 2007–08 to a student, except occasional students, who has achieved the best result in the course 'Competition law'.

The Oldham, Li & Nie Prize in Matrimonial Practice and Procedure

In 2011, The Oldham, Li & Nie agreed to donate until further notice an annual book prize to a Postgraduate Certificate in Laws (PCLL) student who has achieved the highest mark in the course 'Matrimonial practice and procedure'. The prize shall be of the value of \$5,000.

ONC Lawyers Commercial Dispute Resolution Prize

In 2010, ONC Lawyers (the 'Donor') agreed to donate until further notice an annual prize of HK\$10,000 to a student registered for full-time or Year Two part-time Postgraduate Certificate in Laws (PCLL) at the University of Hong Kong.

Pauline Ling Prize in Introduction to Legal Theory

In 1992, Mr David Ling, in memory of his mother, donated an annual prize of \$1,000 to the University for award to an LLB student who has achieved the best performance in the course 'Introduction to legal theory'.

The Personal Injuries Elective Prize

In 2010, The Hon Mr Justice Mohan Bharwaney agreed to establish a prize with his salary for teaching Postgraduate Certificate in Laws (PCLL) course(s) in the Department of Professional Legal Education since the academic year 2009–10 for award to two PCLL students who have achieved the highest mark in the elective course 'Personal injuries'.

Peter Willoughby Medal and Memorial Prize in Tax Law

Peter Willoughby Memorial Prize for Criminal Law I and II

The Peter Willoughby Memorial Fund was established in April 2000 for the purpose of, *inter alia*, awarding a prize of the value of \$2,000 annually to a student who has achieved the highest mark or grade in the examination in the course 'Criminal law I and II'. In 2007, the donor agreed to award the prize to students registered for LLB , BBA(Law), BSocSc(Govt&Laws) or BEng(CivE-Law).

Peter Willoughby Memorial Prize for Property Law I and II

The Peter Willoughby Memorial Fund was established in April 2000 for the purpose of, *inter alia*, awarding a prize of the value of \$2,000 annually to a student who has achieved the highest mark or grade in the examination in the course 'Property law I and II'. In 2007, the donor agreed to award the prize to students registered for LLB , BBA(Law), BSocSc(Govt&Laws) or BEng(CivE-Law).

Peter Willoughby Memorial Prize for Tax Law

The Peter Willoughby Memorial Fund was established in April 2000 for the purpose of, *inter alia*, awarding a prize of the value of \$3,000 annually to a student registered for any taught postgraduate programmes offered by the Faculty of Law who has achieved the highest mark or grade in the course 'International tax and tax planning'.

Privacy Commissioner Prize in Privacy and Data Protection Law

In 2012, the Office of the Privacy Commissioner for Personal Data of the Hong Kong SAR agreed to donate a prize of the value of \$5,000 with effect from the academic year 2012–13, to be awarded annually to students registered for any undergraduate and taught postgraduate programmes organized by the Faculty of Law.

Richards Butler Prize in Admiralty/Shipping Law

In 1989, Richards Butler, Solicitors in Hong Kong, donated an annual prize, payable in the form of books of the value of \$2,500, for award to the student achieving the highest standard in the LLM degree course 'Admiralty or shipping law'.

Richards Butler Prize in Commercial Law and Practice

In 1989, Richards Butler donated an annual book prize of \$5,000 for the PCLL course 'Commercial law and practice'.

Robertsons Prize

In 1999, Robertson Double & Lee established one prize to be awarded to a PCLL student with effect from the academic year 1999–2000. In 2000, the prize was re-named as Robertsons Prize to reflect the change of the firm from Robertson Double & Lee to Robertsons.

Rowdget W. Young Medal in Law

In 1982, Mr Rowdget W. Young donated a sum to the University for the establishment of a prize in the form of a gold medal.

SKYS Prize for PRC Commercial Law

In October 2004, Messrs So Keung Yip & Sin offered to donate an annual prize of \$3,000 to the University of Hong Kong for award to an LLB student who has achieved the best result in the course 'PRC commercial law'.

The SMA Edlyn Yap Prize for Litigation

In April 2005, Sweet & Maxwell Asia (SMA), a Hong Kong-based publisher, agreed to set up a prize annually for a student registered for the Postgraduate Certificate in Laws (PCLL) at the University of Hong Kong. The prize is established in memory of the late Miss Edlyn Yap who was working for Sweet & Maxwell Asia and who passed away during the Asian Tsunami, and to honour her contribution to Hong Kong's legal community.

Smith, Lyons Prize in Civil Litigation

In 1992, Smith, Lyons, Torrance, Stevenson & Mayer, Barristers & Solicitors provided a prize annually for a student registered for the degree of LLB who has achieved the best performance in the course 'Civil litigation' as part of the LLB curriculum.

Simon K.Y. Lee Medal in Law

In 1971, Mr Simon K.Y. Lee donated a sum of money to the University for the establishment of a prize in law, in the form of a gold medal.

Stikeman Elliot Prize in International Trade Law

In 1983, Stikeman Elliot, Canadian Barristers and Solicitors, donated an annual sum of \$1,000 for a prize to be awarded to a student reading for the degree of LLB.

Sun Wah Hi-Tech Prize in Information Technology Law

In 2000, Sun Wah Hi-Tech Group, a Hong Kong-based technology group of companies donated a prize of the value of \$3,000 as an annual award to a LLM student who has achieved the highest mark or grade in the examination in the course 'Information technology law'.

The Sweet & Maxwell Edlyn Yap Prize Litigation

In April 2005, Sweet & Maxwell, a Hong Kong-based publisher, agreed to set up a prize annually for a student registered for the Postgraduate Certificate in Laws at the University of Hong Kong. The prize is established in memory of the late Miss Edlyn Yap who was working for Sweet & Maxwell and passed away during the Asian Tsunami and, to honour her contribution to Hong Kong's legal community.

Temple Chambers International Mooting Prize

With effect from the year 2003, Temple Chambers donated a prize annually to the Faculty of Law to be awarded to the students from the Faculty of Law succeeding in the Jessup International Mooting competition.

Tse Cheuk Ng Tai Prize in Environmental Law

In 2011, Mr Paul C.W. Tse agreed to donate a prize of the value of \$5,000 to be awarded annually from the academic year 2011–12 to students registered for any undergraduate and taught postgraduate programmes organized by the Faculty of Law.

Vivien Chan Prize in Civil Procedure

In 1992, Vivien Chan & Co. provided a prize of \$2,000 annually for a PCLL student who has achieved the best performance in the civil procedure segment of the 'Civil and criminal procedure' course as part of the PCLL curriculum. In 1997, the value of the prize was increased to \$2,500.

Vivien Chan Prize in Company Law

In 1992, Vivien Chan & Co. provided a prize of \$2,000 annually for an LLB student who has achieved the best performance in the course 'Company law' as part of the LLB curriculum. In 1997, the value of the prize was increased to \$2,500.

Vivien Chan Prize in International Commercial Transactions

In 1992, Vivien Chan & Co. provided a prize of \$2,000 annually for an LLM student who has achieved the best performance in the course 'International commercial transactions' as part of the LLM curriculum. In 1997, the value of the prize was increased to \$2,500.

Warren Chan Prize for Postgraduate Diploma in Common Law

In November 1999, Mr Warren C.H. Chan, SC donated a prize of the value of \$3,000 for award annually to a student registered for the Postgraduate Diploma in Common Law (PDipCL).

Winston Chu & Company Prize in Law

In 1991, Winston Chu & Company provided a prize of the value of \$2,500 annually for the next four years for an LLM student who has produced the best dissertation in the LLM curriculum. In 1998, the donor made a further donation of \$10,000 for the prize annually for the next four years. In 2002, the donor agreed to make another donation of \$10,000 for the prize annually for the next four years. The donor further agreed that the eligibility of the prize shall be extended to a student registered on any of the LLM specialist programmes.

Woo Po Shing Medal in Law

In 1982, Mr Woo Po Shing donated a sum of money to the University for the establishment of a prize in law to be awarded in the form of a gold medal.

Y.M. Wong Memorial Prize

In 1981, the family of the late Mr Y.M. Wong donated a sum of \$10,000 to establish a prize in the form of legal textbooks.

PRIZES TENABLE IN THE LI KA SHING FACULTY OF MEDICINE

3M Hong Kong Prize

The Prize, established in 1981 in the form of a stethoscope donated by the 3M Far East Company Limited, is awarded annually to each of the three students who have obtained the best overall academic performance in the First, Second, Third and Final Examination.

The Agilent Prize in Chemical Pathology and Toxicology

In 2010, the Agilent Technologies Hong Kong Limited agreed to donate an annual sum for the establishment of The Agilent Prize in Chemical Pathology and Toxicology. The Prize shall be awarded with effect from 2009–10.

American College of Chest Physicians Prize

In 1982, the American College of Chest Physicians (Hong Kong and Macau Chapter) donated an annual sum to establish a prize to be awarded each year for the best essay on any subject related to cardio-respiratory medicine.

Belilios Medical Prizes

Under trusts founded by Mr Emanuel Raphael Belilios in 1883 and 1891 two awards were provided for students attending the Hong Kong College of Medicine for Chinese. When the College of Medicine was incorporated into the University of Hong Kong the benefits of the trusts were transferred to the University for scholarships. Since 1973, following a reorganization of the trusts, two prizes are available each year: one for award to a student admitted from Queen's College who obtained the best results in class tests held in the first year, and one for the student securing the highest aggregate of marks in the Second MBBS Examination. In 2000, the eligibility criteria was revised such that one prize shall be awarded on the basis of performance in the First Summative Examination for a first year student, whilst the other prize shall be awarded to a student in the third year based on the aggregate marks in the Third Summative Examination.

BL Wong Prizes

In 1997, Mr B.L. Wong donated a sum of \$200,000 to establish two prizes to be awarded to the MBBS student who has achieved the best performance in the clinical skills session of MBBS Year One and the other to be awarded to a medical student who has achieved the best overall result in the MBBS First Examination.

BL Wong Prizes in Nursing Studies

In 2000, Dr Wong Bing Lai and his sons, Messrs Wong Tat Chang, Abraham, Wong Tat Kee, David and Wong Tat Sum, Samuel, donated a sum of \$200,000 to establish two prize awards.

BL Wong Prize in Nursing Studies (Clinical Excellence)

In 2008, Dr Wong Bing Lai and his sons, Messrs Wong Tat Chang, Abraham, Wong Tat Kee, David and Wong Tat Sum, Samuel agreed to donate a sum of \$100,000 to establish a prize with effect from the academic year 2009–10.

BL Wong Prize in Nursing Studies (Master of Nursing)

In 2008, Dr Wong Bing Lai and his sons, Messrs Wong Tat Chang, Abraham, Wong Tat Kee, David and Wong Tat Sum, Samuel agreed to donate a sum of \$100,000 to establish a prize with effect from the academic year 2009–10.

C. Elaine Field Gold Medal in Paediatrics

In 2002, a fund of about \$180,000 was donated by the former associates of Professor C. Elaine Field to establish the C. Elaine Field Gold Medal in honour of Professor Field (Founding Professor of Department of Paediatrics 1962–71).

C.P. Fong Gold Medals

A fund was established from donations by patients, practitioners and students in memory of Fong Chun Piu, MBBS to provide for two prizes, in the form of a gold medal, to be awarded annually to students who have obtained the highest places in the Second MBBS Examination in pathology and in the Final Examination in medicine, respectively.

C.T. Huang Gold Medal in Microbiology

The Prize, established in 1978 to mark the retirement of Emeritus Professor C.T. Huang of the Department of Microbiology, is awarded annually to the student who has secured the highest place in the Second MBBS Examination in microbiology.

Digby Memorial Medal

The Prize, in the form of a gold medal awarded annually to the student who has secured the highest place in the Final MBBS Examination in surgery, was established through donation to perpetuate the memory of K.H. Digby (Professor of Anatomy from 1913 to 1923, Professor of Surgery from 1923 to 1941, and Emeritus Professor from 1950 to 1954).

Dr Avery S.C. Chan Prize in Dermatology

In 1998, the MBBS class of 1977 (Medic '77) donated a sum of \$50,000 to the Faculty for the establishment of a prize in commemoration of Dr Avery S.C. Chan.

Dr Kate Cheng Memorial Prize for Postgraduate Diploma in Infectious Diseases

In 2003, the MBBS Class 97 and the staff in the Tai Po Hospital donated a sum to establish a prize to commemorate the selfless devotion and contribution of Dr Cheng Ha-yan, Kate, who contracted SARS while on duty as a Medical Officer at the Tai Po Hospital and passed away in June 2003. Dr Cheng graduated with the MBBS degrees in 1997. She was also enrolled in the Postgraduate Diploma in Infectious Diseases Programme at the University of Hong Kong in 2002.

Dr K.P. Stephen Chang Gold Medal

In 1993, the MBBS class of 1958 donated twenty gold medals to the Faculty to be awarded annually to the candidate who has written the best PhD thesis.

Dr Mary Hui Ling Li Memorial Prize

The Prize, established in 1971 with a donation from Mr Kwei Wah Shan, is awarded annually for the most original essay on any subject within the curriculum or on clinical observation and /or research.

Dr P.P. Chiu Prize in Family Medicine

The Dr P.P. Chiu Prize in Family Medicine was established in 2012 to perpetuate his memory by his children and Professor Sir David Todd, who donated \$100,000 to initiate the fund.

Dr Sun Yat Sen Prize in Clinical Surgery

In 1990, a sum of \$20,000 was donated to the University by Mr and Mrs Martin N. Leeds to establish a prize in appreciation of the clinical care rendered by Professor John Wong and Dr M.W. Tsang. The Prize will be awarded annually to a final-year MBBS student who has attained the best result in clinical surgery.

Eisai Prize in Clinical Pharmacy

In June 2012, Eisai (HK) Company Limited agreed to make a donation to set up a prize tenable to students of the Bachelor of Pharmacy curriculum.

Gordon King Prize in Obstetrics and Gynaecology

The Prize, established through a sum of money subscribed by former students of the University who continued their studies during the war, is awarded annually to the student who has secured the highest place in the Final MBBS Examination in obstetrics and gynaecology.

H.C. Liu Prizes in Anatomy

In 1985, to mark her retirement from the University after many years of distinguished service to the University, friends and colleagues of Dr H.C. Liu donated a sum of money to establish two prizes in anatomy.

Ho Fook and Chan Kai Ming Prizes

The Prizes were established in 1916 with a donation from the late Mr Ho Fook and the late Mr Chan Kai Ming. The Ho Fook Prize and the Chan Kai Ming Prize are awarded annually by the Board of Examiners for the MBBS Second Summative Examination to the candidate who has obtained the highest aggregate mark in the First and Second Summative Examinations; and for the Final Examination on the results of the Final MBBS Examination in the subjects, medicine, surgery, obstetrics and gynaecology, the paediatrics, all passed at the first attempt, respectively. In 1998, the value of the prizes was increased to \$700 each.

Ho Kam Tong Prize in Community Medicine

The Prize was established in 1941 with a donation from Mr Ho Kam Tong for award annually to the student who has secured the highest place in the Third MBBS Examination in community medicine.

Ho King Mau Memorial Prize

In 2002, the immediate family (his wife Madame Man Lan Ying and two sons, Drs Ho Koon Piu and Ho Koon Ki, Tommy) of the late Mr Ho King Mau, offered to establish a prize in memory of Mr Ho through a donation of \$100,000 to the University of Hong Kong. The prize shall be awarded to the student who has achieved the best overall results in the MBBS Second Summative Examination.

Ho Koon Kui Memorial Prize

In 1997, Dr Ho Koon Piu of the Department of Chinese of the University donated a sum of \$50,000 for the establishment of a prize in memory of his late brother, Mr Ho Koon Kui, to be awarded to the student who has obtained the best overall results in the MBBS Final Examination.

Hong Kong College of Family Physicians' Prizes

In 1981, the Hong Kong College of Family Physicians donated an annual sum for an indefinite period to establish a prize to be awarded to a student who has demonstrated special interest and skill in an approved investigation into aspects of general practice. In 1990, the donor awarded an additional prize for the best community based research work. In 1997, the prizes were renamed the Hong Kong College of Family Physicians' Prizes following the change of the College's title. The value of each prize has been increased to \$5,000 each year with effect from 2000–01.

Hong Kong College of Paediatricians Prize in Clinical Paediatrics

In 2003, the Hong Kong College of Paediatricians agreed to donate an annual sum to establish a prize of the value of \$3,000 (adjustable from time to time) for award to the top student in Clinical Paediatrics.

The Hong Kong College of Psychiatrists Prize

In 2008, The Hong Kong College of Psychiatrists agreed to donate an annual sum to establish a prize of \$2,000 for award to the top student in Psychiatry with effect from 2008–09.

Hong Kong Medical Association Prize

The Prize, established in 1970 with a donation from the Hong Kong Medical Association, is awarded annually for the most original essay on any subject within the curriculum or on clinical observations and/or research. In 1997, the donor increased the annual value of the prize to \$5,000.

Hong Kong Pathology Society Prize

The Prize, established in 1983 to mark the retirement of Professor J.B. Gibson, is awarded to the student who has attained the second highest cumulative mark in the pathology component of the written examinations in the First, Second and Third Summative Examinations, and whose total mark in all subjects in these three years is among the top 10% of the class.

Hong Kong Society of Community Medicine Prize

The Prize is awarded annually either to an individual medical student or to a group of medical students who have demonstrated special interest and skill in an approved assignment in the field of community medicine.

The Hong Kong Society of Medical Genetics Prize

In 1992, the Hong Kong Society of Medical Genetics established a prize of \$500 for award to the student who has achieved the best overall performance in Human Genetics in the Second Year Class Test at first attempt.

Jacobson Prize in Pharmaceutical Science

In April 2012, Jacobson Pharma Group agreed to make a donation to set up a prize tenable to students of the Bachelor of Pharmacy curriculum.

Janet McClure Kilborn Prizes

The Prizes, established through a sum bequeathed by the late Dr Janet McClure Kilborn for the West China Union University and transferred to the University of Hong Kong through the efforts of Professor L.G. Kilborn, are awarded annually to two female students on the basis of their performance in the First and Second Summative Examination in the Department of Biochemistry and Physiology, respectively.

John Anderson Gold Medal

The Prize, in the form of a gold medal, was established in 1967 with a donation from the late Dr John Anderson for award annually to the student who has secured the highest aggregate of marks in all the MBBS professional examinations.

Bronze medal. Dr D. Hunt of the Royal Melbourne Hospital, Visitor under the Leverhulme Medical Interchange Scheme in 1967, donated a sum to provide a bronze medal for a proxime accessit to the Anderson Medal winner.

Lau Wing Kai Memorial Prizes

In 2003, the Department of Nursing Studies established three prizes to commemorate the selfless devotion of Mr Lau Wing Kai, who was a male nurse who died of SARS in April 2003 after having been infected by a SARS patient whom he had tried to resuscitate. Funding of the prizes is from generous donations by the public.

Lee Kuok Si Prizes (李國師獎學金)

In 2012, Mr Lee Kuok Si decided to make a regular donation each year to set up Lee Kuok Si Prizes.

Li Shu Fan Medical Foundation Prizes

The Prizes, established in 1963 with a donation from Dr Li Shu Fan, are awarded annually to students who have secured the highest places in physiology, biochemistry and pharmacology in the First and Second Summative Examinations.

Madame Yuen Poon Chee Memorial Prize

In 2000, Mr Ho Koon Ki, Tommy, and his wife donated a sum of \$100,000 for the establishment of a prize in memory of Mr Ho's late grandmother-in-law, Ms Yuen Poon Chee. The prize shall be awarded to the student who has obtained the best overall results in the Final MBBS Examination in 'Obstetrics and gynaecology'.

Medic '67 Gold Medal in Clinical Medicine

In 1998, the MBBS class of 1967 donated ten gold medals to the Faculty for establishing a Gold Medal for award to the top student in clinical medicine. The award shall be initially for a period of ten years, from 1998 to 2007.

Medic '71 Dean's Prize for Community Projects

In 1996, a sum of \$50,000 was donated to the University by the medical graduates of the year 1971 to establish a prize for award to an individual or a group of medical students who have produced an outstanding community project which should essentially be: (a) an original project; (b) done entirely or mostly by current medical student; (c) focusing on health issues of the community; and (d) well documented and presented.

Medic '71 Prize in Medical Jurisprudence

In 1992, a sum of \$50,000 was donated to the University by medical graduates of the year 1971 to establish a prize for award to a medical student who has achieved outstanding performance in the Special Study Module in Medical Jurisprudence or a project in related fields.

Medic '71 Prize in Nursing Studies

In 1997, the medical graduates of the year of 1971 donated a sum of \$50,000 to establish two Medic '71 Prizes in Nursing Studies for award to a second-year and a final-year student who have attained the highest total aggregate of marks in the respective examinations.

Mun Gold Medal and Prize in Psychiatry

The Prize established through an anonymous donation, is awarded annually for the purpose of encouraging the study of psychiatry. The Prize is in the form of a gold medal, with a sum for purchase of books.

Nesta and John Gray Medal in Surgery

The Prize, in the form of a gold medal, was established in 1974 with a donation from Dr H.S.Y. Fang in memory of Dr and Mrs John Gray for award annually to the student who has obtained the highest aggregate of marks in the Final MBBS Examination in surgery.

Ng Li Hing Prize

Under trust inherited from the Hong Kong College of Medicine, a prize is awarded annually to the student who has attained the highest aggregate overall mark in the Anatomy component of the knowledge-based assessment in both the First and Second Summative Examinations.

Paediatric Respiriology Award

In 2005, the Hong Kong Society of Paediatric Respiriology pledged an annual award of \$2,000 to a MBBS student for the best essay in paediatric respiratory medicine, preferably with relevance to Hong Kong.

The Pharmaceutical Society of Hong Kong Prize

In March 2012, the Pharmaceutical Society of Hong Kong, agreed to make a donation to set up a prize tenable to students of the Bachelor of Pharmacy curriculum.

Pharmaceutics Laboratory Prize

In June 2012, a group of benefactors pledged to donate \$26,000 to establish the Pharmaceutics Laboratory Prize for students enrolling in the Bachelor of Pharmacy curriculum.

Pong Ding Yuen Prizes in Chinese Medicine

In 2000, the Pong Ding Yuen family made a generous donation of \$10 million to set up a permanent Pong Ding Yuen Endowment Fund for Education and Research in Chinese-Western Medicine at the School of Chinese Medicine. Committee of Management of the School of Chinese Medicine resolved to set up two 'Pong Ding Yuen Prizes in Chinese Medicine'.

The Practising Pharmacist Association of Hong Kong Prize

In February 2012, the Practising Pharmacist Association of Hong Kong agreed to donate on a yearly basis to set up a prize tenable to students of the Bachelor of Pharmacy curriculum.

Principal Ho Sheung-Kwan Award of Excellence for Bioinformatics

The Homantin Government Secondary School Alumni Association established an Award of Excellence for Bioinformatics in 2004 on behalf of Mr Ho Sheung-Kwan, its first Principal of the School. The Award, of the value of \$1,500, shall be available for annual award to students who are reading the Bachelor of Science in Bioinformatics.

Professor Anthony Hedley Prize for Master of Public Health

In 2002, Professor T.H. Lam, Professor A.J. Hedley and their colleagues and friends established a prize to commemorate the retirement of Professor A.J. Hedley from the headship of the Department of Community Medicine (1988–2000), through an initial donation of \$20,000. The prize, of the value of \$2,000, shall be awarded annually to the Master of Medical Sciences (MMedSc) student who has obtained a distinction award and the highest weighted average mark in the overall results in the subject of public health (including course work and dissertation). With the offering of the Master of Public Health in 2004, the prize was re-named as the Professor Anthony Hedley Prize for Master of Public Health.

Professor Michael Colbourne Prize

In 2000, the Professor Michael Colbourne Prize was established in commemoration of Professor Michael Colbourne, a previous Head of the Department of Community Medicine. The value of the prize shall be \$1,500 and shall be awarded to an individual or a group in Year Two or Three of the MBBS curriculum who has/have produced an outstanding piece of work in any of the sections of the curriculum administered by the Department of Community Medicine.

Professor Paul M. Vanhoutte Prize in Pharmacology

In 2010, colleagues and postgraduate students in the Department of Pharmacology and Pharmacy resolved to pledge \$30,000 for an annual award of \$2,000 for 15 years to establish the Professor Paul M. Vahoutte Prize in Pharmacology. The prize shall be awarded with effect from the academic year 2011–12.

Professor S.P. Chow Prize in Orthopaedics & Traumatology

In 2010, the Committee of Management of the Professor SP Chow Education Fund in Orthopaedic Surgery resolved to pledge an annual award of \$3,000 for the establishment of the Professor S.P. Chow Prize in Orthopaedics & Traumatology. The value of the Prize shall be \$3,000.

R.M. Gibson Gold Medal in Paediatrics

The R.M. Gibson Gold Medal in Paediatrics, presented by Dr T.Y. Li in memory of Dr R.M. Gibson (medical superintendent of the Alice Ho Miu Ling Nethersole Hospital from 1897 to 1918 and again from 1926 to 1935, and part-time lecturer in Surgery), is awarded annually to the student who has secured the highest place in the Final MBBS Examination in paediatrics.

The Roche Prize in Chemical Pathology

In 2009, the Roche Diagnostics (Hong Kong) Ltd agreed to donate an annual sum for the establishment of the Roche Prize in Chemical Pathology. The Prize, of the value of \$10,000, shall be awarded with effect from the academic year 2011–12.

Serena Yang Prizes in Nursing Studies

In 2004, Ms Serena Yang, through her association with Professor Farideh Salili of the Department of Nursing Studies, agreed to establish six prizes, through a donation of \$1 million to be awarded annually to six full-time undergraduate students who are reading the degree of BNurs (full-time) Programme with effect from the 2004–05 academic year. The value of each of the prizes in any year shall normally be at \$6,000.

Serena Yang Prizes for BNurs (Part-time) Programme for Enrolled Nurses

In 2010, Dr Serena Yang donated a sum of \$1 million to the School of Nursing to support and recognize academic pursuits and outstanding achievements by students in both undergraduate and postgraduate levels.

Serena Yang Prizes for Clinical Excellence Awards for the BNurs (Full-time) Programme

In 2010, Dr Serena Yang donated a sum of \$1 million to the School of Nursing to support and recognize academic pursuits and outstanding achievements by students in both undergraduate and postgraduate levels.

Sir Patrick Manson Gold Medal

The Prize, established in 1972 with a donation from Mrs Yu Ping Keung, is awarded for outstanding merit in a thesis submitted for the degree of MD.

Sister Mary Aquinas Prize

In 1999, the Hong Kong Tuberculosis, Chest and Heart Diseases Association established three prizes for award each year from 1999–2000. The value of the first prize shall be \$3,000, the second prize \$2,000 and the third prize \$1,000. The total value of the three prizes has been increased to HK\$10,000 each year with effect from 2009–10. The value of the first prize shall be increased to HK\$5,000, the second prize \$3,000 and the third prize \$2,000.

Teng Pin Hui Prize in Community Medicine

The Teng Pin Hui Prize in Community Medicine was established in 1995, with an anonymous donation, in commemoration of Professor Teng Pin Hui. The Prize, in the form of a bronze medal and \$10,000 cash is for award to the student who achieves the best total scores in the course assessment and examination in Health, Behaviour and Medical Care, for work in years I to IV.

The Tse Cheuk Ng Tai Prize in Liver Cancer Research

In 2011, Mr Paul C.W. Tse donated a sum of \$50,000 for the establishment of the Tse Cheuk Ng Tai Prize in Liver Cancer Research. The Prize shall be awarded for 10 years subject to renewal with effect from the 2011–12 academic year. Competition for the prize shall be open to all MBBS undergraduates, postgraduates, and graduates of the Medical Faculty within four years of their completion of the compulsory period of pre-registration employment in a resident medical capacity. The value of the Prize shall be \$5,000.

W.D. Low Prizes in Anatomy

In 1986, friends, colleagues, and students of the late Dr W.D. Low donated a sum of over \$45,000 for the purpose of establishing two prizes in memory of Dr Low, a distinguished teacher in the Department of Anatomy from 1964 to 1985.

Woo Kai Fun Prize in Clinical Neurology

The Prize, established in 1970 with a donation from Dr Woo Kai Fun, is awarded for the best essay or commentary on clinical neurology.

Yuan Ai-Ti Gold Medal in Behavioural Sciences

In 1979, the family and friends of the late Dr Yuan Ai-Ti (Mrs T.W. Wu) donated a sum for the establishment of a prize in the form of a gold medal in her memory. The medal shall be awarded to a second-year MBBS student who has performed well in the First and Second Summative Examinations and who has achieved the best overall performance on the basis of a piece of written work and the viva voca.

Yu Chiu Kwong Gold Medal in Clinical Medicine

In 2007, a sum of \$130,000 was donated to the University by the friends and colleagues of the late Dr Yu Chiu Kwong to establish the Yu Chiu Kwong Gold Medal in Clinical Medicine which shall be awarded annually with effect from 2007–08.

PRIZES TENABLE IN THE FACULTY OF SCIENCE*Ada and Arthur Hill Prize in Environmental Management*

In celebration of the 50th Anniversary of the Faculty of Science in 1989, the family of Ada and Arthur Hill donated a sum of \$10,000 for the establishment of a prize in Environmental Management to be named in their honour to mark the launching of the inter-faculty multi-disciplinary MSc(EnvMan) degree programme, the first of its kind in Hong Kong.

Alan John Ellis Prizes in Mathematics

In 1992, a group of former friends and students of the late Professor Alan John Ellis raised a fund of over \$120,000 in his memory for the establishment of mathematics prizes to be awarded annually.

BSc Class of 1971 Prize

In 1992, twenty-three members of the BSc class of 1971 donated a sum of \$24,000 for the establishment of a prize in the Faculty of Science. A sum of \$70,000 was further donated in 2002.

C.K. Leung Awards for Academic Achievements

Daniel K.O. Chan Award for Outstanding Student in Biological Sciences

In celebration of the 70th Anniversary of the Faculty of Science, a student award has been established to honor Professor Daniel K.O. Chan, the Emeritus Professor and retired Head of the Zoology Department who has made significant contributions in research and teaching in the School of Biological Sciences. With the support of our colleagues, alumni, and long-germ friends in sister universities, a total donation of \$265,600 has been received as the seed funding for the award.

Dick Arthur Memorial Prize

In 1971, a fund of over \$4,600 was raised by friends of the late Mr H.R. Arthur for the establishment of a prize in his memory. Mr Arthur had served the University from 1951 to 1968 when he retired as Reader in Organic Chemistry.

Douglas Payne Prizes in Chemistry

In 1982, a sum of \$10,800 was raised by former students of Professor Douglas Payne, Professor of Chemistry from 1966 to 1982, for the establishment of two prizes in Chemistry in his honour.

Dr Spring Chen Memorial Prizes in Botany

In 1987, the Dr Spring Chen Scholarship Trust donated three annual prizes in memory of the long association of the late Dr Spring Chen with the University. In 2001, the Dr Spring Chen Scholarship Trust was voluntarily wound up in March 2001. In accordance with the provisions of the Trust Deed of the Dr Spring Chen Scholarship Trust dated April 1, 1987, the balance available (\$362,675.74) upon the voluntary winding up of the Trust would be paid to the University of Hong Kong.

Fred Kan & Co. Prize

In 1993, Fred Kan & Co. donated a sum of \$5,000 for the establishment of a prize to be awarded annually to the student who submits the best MSc(EnvMan) dissertation concerning environmental law or environmental policy. In 1996, the value of the prize was increased to \$6,000.

Fung Leung Chee Wai Diana Prize in Earth Sciences

Ms Grace Fung Shuk Yun donated a sum of \$200,000 for the establishment of a prize in Earth Sciences to be named in honour of her mother, Mrs Fung Leung Chee Wai Diana.

G.T. Byrne Memorial Prize in Chemistry

In 1964, a fund of over \$7,500 was raised by former students and friends of the late Professor G.T. Byrne, Professor of Chemistry from 1919 to 1944, for the establishment of a prize in his memory. Accumulated income over the years has resulted in a significant enhancement in the capital sum.

Halcrow Prizes for MSc Students

In 2000, Halcrow China Limited established two prizes to be awarded annually, with effect from the 1999–2000 academic year, to students who perform particularly well on the MSc in Applied Geosciences.

Ho Fook and Chan Kai Ming Prizes

Two prizes of the value of \$350 each are awarded each year in the Faculty of Science. In 1998, the value of the two prizes was increased to \$700 each.

Hong Kong Natural History Society Prize for Outstanding Student in Ecology and Biodiversity

The Hong Kong Natural History Society has donated \$10,000 for the establishment of a prize in memory of the Society's former Chairman, the late Mr David England.

Ho Sin Hang Prize in Science

In 1951, Mr Ho Sin Hang gave a sum of \$10,000 for the establishment of a prize equal to the value of the interest thereon.

Lam Chi Him Memorial Prize in Physics

In 1999, the Executive Members of the 1977 Science Society established a prize in memory of Mr Lam Chi Him who had graduated with a BSc degree in Physics from the University in 1979, and who was also the Vice-Principal of the Tung Wah Group of Hospitals Wong Fut Nam College. A sum of \$230,000 was donated in 2007 as endowment for the prize.

Lam Fang Kwong Prize in Physics

In celebration of the 50th Anniversary of the Faculty of Science in 1989, a science graduate Mr Lam Chiu Ying donated a sum of \$20,000 for the establishment of a prize in Physics to be named in honour of his father, Mr Lam Fang Kwong. The donor made a further donation of \$1,000 to enable the first award to be made for the academic year 1990–91. Further amounts of \$30,000 and \$180,000 were donated to the fund in 2000 and 2007 respectively.

Lee Chung Yin Jubilee Prize in Zoology

In 1957, to commemorate the Silver Jubilee of the foundation of the Chair of Zoology, Dr Peter C.Y. Lee donated a sum of \$12,000 for the establishment of a prize.

Lifelong Learning Prizes in Statistics

The Department of Statistics and Actuarial Science has made available 15 prizes of the value ranging from \$5,000 to \$10,000 for award in the academic year of 2005–06 to second-year MStat students.

Patrick Chow Lum Wong Memorial Prize in Biochemistry

Friends and well wishers of Dr Patrick C.L. Wong (former Head of the Department of Biochemistry) established a fund in memory of Dr Wong who passed away on May 19, 1998 for the award of prizes to undergraduate students in the Department of Biochemistry from 1998–99 onwards.

Peter Thrower Prize in Botany

In 1992, a former student of this University donated a sum of \$15,000 for the establishment of a prize in Botany.

Professor Brian Morton Undergraduate Prize in Biology and Professor Brian Morton Postgraduate Prize in Marine Biology

In celebration of the 75th Anniversary of the Faculty of Science, the alumni of the former Department of Zoology and staff and long-term friends of the School of Biological Sciences have donated the seed funding to set up an undergraduate prize in Biological Sciences and a postgraduate prize in Marine Biology to honor Professor Brian Morton, Emeritus Professor of Marine Ecology in the former Department of Ecology and Biodiversity, for his significant contributions in teaching and research in marine biology as well as in pioneering the marine environmental conservation in Hong Kong.

Professor C.D. Beling Memorial Prize in Physics

In 2010, Mrs Beling and a group of Professor Beling's students donated \$244,000 to the University of Hong Kong for establishment of the Professor C.D. Beling Memorial Prize in Physics which shall be awarded annually from the academic year 2011–12 until further notice.

Saw Gold Medal in Statistics

Walter Brown Memorial Prizes in Mathematics

Three prizes, of which two shall be for students in the BA or BSc degree curricula and one for a student in the BEng degree curriculum, have been established in memory of Professor Walter Brown (Professor of Mathematics from 1918 to 1946, and Emeritus Professor from 1950 to 1957) by his former students and friends.

William Faid Memorial Prize in Physics

In 1964, Mrs Jeanne Faid, MSc, donated to the University a sum of \$8,000 for the establishment of a prize in memory of her husband, the late Professor William Faid (Professor of Physics, 1924–1944).

Wong Yung Chow Prize in Mathematics

A prize in mathematics was established in 1976 in honour of Professor Y.C. Wong (Professor of Mathematics from 1948 to 1976 and Emeritus Professor from 1976) by his former students and friends.

Y.M. Chen Memorial Prize in Mathematics

In 1986, friends and students of the late Dr Y.M. Chen, Professor of Mathematics from 1974 to 1984, donated a sum of \$23,000 for the establishment of a prize in his memory.

Yung Foundation Earth Sciences Fund

In 2000, the Department of Earth Sciences received from the Yung Foundation, a donation of \$25,000 as a first instalment, and in 2001, an additional sum of \$40,000 was received once in 2001 and later again in 2002 as the second and third instalment towards the Yung Foundation Earth Sciences Fund for the award of prizes and loans annually. In 2003 the Yung Foundation donated \$40,000 being the fourth instalment for the award of prizes and loans annually.

Dr Geraldine Mao-Ng Prizes in Psychology

In 1982, the family and friends of the late Dr Geraldine Mao-Ng, formerly part-time Lecturer in Psychology at the University, donated a sum of money to establish two prizes in psychology.

Dr Stephen S.F. Hui Prizes in Geography

In 1999, Mr Richard Hui and Mr William Hui of Sze Cheong Investment Co. Limited donated a series of prizes to the University to be awarded annually from 1998–99 onwards to undergraduate and postgraduate students.

*Ellen Koo Prize in Social Sciences**Jao Tao Su Prize in Economics*

In memory of his late parents, Professor Y.C. Jao, Honorary Professor and former Reader in the School of Economics and Finance, made a donation for the establishment of the two Prizes in 1992 and subsequent donations in 2008 and onwards.

Erik Kvan Memorial Book Prizes

In 2003, the Erik Kvan Memorial Book Prizes was established from donations received from friends, former colleagues and students in memory of the late Dr Kvan. One book prize shall be awarded to a postgraduate research student in the Department of Social Work and Social Administration, the other be awarded to a postgraduate student reading the MSocSc in Counselling in the Department of Social Work and Social Administration.

*Father Cronin Memorial Award**Father Cronin Memorial Award (Best Dissertation)*

In 1994, the Hong Kong Housing Society's Executive Committee donated two awards to the University to commemorate the contributions made in the housing field by the late Rev. Fr. F. Cronin, a long serving member of the Committee. The award shall be offered to students reading for the degree of MHousMan.

Henry James Lethbridge Memorial Book Prize

In 1992, the Henry James Lethbridge Memorial Book Prize was established from donations received from former colleagues, friends and students of Professor Lethbridge to commemorate his contributions to the development of Sociology in the University and the community. The prize shall be awarded to a BSocSc student who has taken at least eight courses in Sociology.

Ho Fook and Chan Kai Ming Prizes

Four prizes of the value of \$350 each are awarded each year. In 1998, the value of the four prizes was increased to \$700 each.

Hui Oi-Chow Prize in Geography

In 1979, an annual prize of the value of \$500 was established from income from the Hui Oi-Chow Trust Fund for award to a student reading geography and geology. In 2000, the prize was re-named from the Hui Oi Chow Prize in Geography and Geology to the Hui Oi Chow Prize in Geography to reflect the change in the name of the department.

Jean Robertson Memorial Book Prizes

The Jean Robertson Memorial Book Prizes were established in 1976 from donations received from former colleagues, friends, and students, to commemorate the work of Jean Macdonald Robertson, first Professor of Social Work, 1967–72.

The K.K. Ho Prize

In 2001, the K.K. Ho Foundation donated a capital sum of \$10 million to the University of Hong Kong for the establishment of the K.K. Ho Scholarship for academic excellence, the K.K. Ho Prize, the K.K. Ho Bursary, and the K.K. Ho Foundation Emergency Funds, tenable in the Faculty of Social Sciences.

There shall be five prizes each of the value of \$20,000 for students studying for a degree or major offered by the Departments of Politics and Public Administration, Psychology, Sociology, Social Work and Social Administration, and Statistics and Actuarial Science.

Peter Hodge Memorial Book Prize

The Peter Hodge Memorial Book Prize was established in 1984 with donations from former students and friends of the late Professor Peter Hodge, Professor and Head of the Department of Social Work from 1972 to 1984. The prize shall be awarded to a BSocSc student taking at least four social policy and administration courses.

Peter Willoughby Medal and Memorial Prize in Tax Law

Stewart Richards Memorial Prize for Best UK Field Trip Performance

In 1999, Mrs Jean Richards donated a prize to the University in memory of her late husband's enthusiasm for fieldwork and his belief in its importance in the geographical curriculum. The prize will be awarded annually from the academic year 1999–2000 to Geography major students for performance in the United Kingdom field trip courses.

T.N. Chiu Memorial Prize for Best Geography Dissertation

In 1987, colleagues, students and friends of the late Dr T.N. Chiu, a teacher in the Department of Geography and Geology from 1963 to 1985, donated a sum of \$30,310 to establish a prize to be awarded to one or more final-year undergraduate students in the Faculty of Arts taking the equivalent of seven or eight courses in the Department of Geography and Geology, on the examination result of the course 'Dissertation'. In 2000, the prize was re-named from the 'T.N. Chiu Memorial Prize in Geography Dissertation' to the 'T.N. Chiu Memorial Prize for Best Geography Dissertation'. From 2009, the Prize shall be awarded to a final-year undergraduate student majoring in Geography taking a total of 72 credits or more in the second and third years of study in the Department of Geography, one the examination result of the 12-credit course 'Honors dissertation'.

Transport Policy and Planning Dissertation Prize

The Transport Policy and Planning Dissertation Prize is set up by the Department of Geography, with effect from the academic year 2012–13, as a recognition to the student who has produced the highest quality of dissertation in that academic year.

HKU Medical Laboratory Science Graduates' Association Book Prizes

In 1984, the HKU Medical Laboratory Science Graduates' Association donated a sum of \$400 each year until further notice for the establishment of two book prizes to be awarded from 1983–84.

Hong Kong Society of Haematology Book Prize

In 1978, the Hong Kong Society of Haematology donated five prizes in the first instance of \$100 each.

Hong Kong Society of Microbiology Book Prize

In 1984, the Hong Kong Society of Microbiology donated a sum of \$300 each year until further notice for the establishment of a book prize to be awarded from 1984–85 for the best performance in the final microbiology examination of the Higher Certificate in Medical Laboratory Technology course.

Personnel Management Club Prize

In 1978, the Personnel Management Club in Hong Kong provided a prize from 1978 to be awarded each year. The prize shall comprise a plaque and a sum of \$250.
