
PROFESSIONAL RECOGNITION

Accounting, Business and Economics

The Faculty of Business and Economics is awarded accreditation by both the US-based Association to Advance Collegiate Schools of Business (AACSB International) and the European Quality Improvement System (EQUIS) managed by the European Foundation for Management Development (EFMD).

The BBA(Acc&Fin) and BBA(Law) with a professional core in Accounting degree programmes have been accredited as approved accountancy degree programmes under the Professional Accreditation System of the Hong Kong Institute of Certified Public Accountants (HKICPA). BBA(Acc&Fin) and BBA(Law) with a major in Accounting graduates may undertake the CPA Qualification Programme, which comprises the Professional Programme and the Final Professional Examination. BBA(Acc&Fin) and BBA(Law) with a professional core in Accounting graduates are exempted from the fundamental level of the Association of Chartered Certified Accountants (ACCA) examination scheme. They must take all the non-exemptable papers in the professional level to fulfill the examination requirement for ACCA membership. BBA(Acc&Fin) and BBA(Law) with a professional core in Accounting graduates are eligible for Associate Membership of CPA Australia provided that they completed all required core curriculum subject. They can complete the CPA Programme and advance to CPA status in the manner stipulated by the CPA Australia. All BBA graduates are eligible for earning the Chartered Global Management Accountants (CGMA), with part of the CIMA examinations exempted, provided that they completed all required subjects specified in the CIMA mapping guidance. The BBA with a major in Human Resource Management degree programmes has been endorsed as approved degree programmes under the Hong Kong Institute of Human Resource Management (HKIHRM). Details of the above programme can be found by accessing the HKIHRM website: <http://www.hkihrm.org/>.

The BBA(IS)/BEng(CS) programme is accredited by the Hong Kong Institute of Engineers. Graduates of the programme meet the academic requirements for Member of the HKIE in the Information Discipline. Details of the above accreditation can be found by accessing the HKIE website: <http://www.hkie.org.hk/>.

The BBA(IS)/BEng(CS) programme is in alignment with the ISACA Model Curriculum for IS Audit and Control. Graduates of the programme qualify for one year work experience toward the Certified Information Systems Auditor (CISA) designation. The BSc(QFin) programme became the first undergraduate QFin programme in Asia, Europe, and North America to be accredited by the Professional Risk Managers International Association (PRMIA). Studying in a programme accredited by PRMIA, students of BSc(QFin) are granted exemption from Paper I and Paper II of the Professional Risk Manager (PRM) Programme, which leads to the professional qualification of PRM. Actuarial Science

The BSc(ActuarSc) programme has been accredited by the Institute and Faculty of Actuaries (IFA), students in the programme will be recommended for exemptions by IFA for subjects CT1–CT8, or some subjects of CT1–CT3 and CT5–CT7.

The BSc(ActuarSc) graduates who attain a B- or higher standard in appropriate courses may obtain Validation by Educational Experience (VEE) credit from the following courses of the Society of Actuaries in the United States: Applied Statistical Methods, Corporate Finance, and Economics.

The BSc(ActuarSc) programme has also met strict criteria set by the Society of Actuaries, United States, in terms of quality of curriculum, number and quality of graduates, qualified faculty, strong ties to business, and beneficial research and scholarship. In this regard, the Department of Statistics and Actuarial Science was designated as a Centre of Actuarial Excellence by the Society of Actuaries for a period of five years.

Architecture

The professional degree of Master of Architecture (MArch) is recognized by the Hong Kong Institute of Architects (HKIA), Architects Registration Board (ARB) and the Commonwealth Association of Architects (CAA). Upon passing the Professional Assessment held by HKIA/ARB in Hong Kong, graduates are eligible to apply for admission as Members of HKIA and as Registered Architects under the Architects Registration Ordinance (Chapter 408).

The Master of Landscape Architecture (MLA) is a professional degree, accredited by the Hong Kong Institute of Landscape Architects (HKILA).

After two years approved practical experience, MLA graduates are eligible to sit HKILA Professional Practice Examinations in order to gain full professional status, and subsequently apply to become a Registered Landscape Architect (LA) in Hong Kong.

Chinese Medicine

Students who are registered in the Bachelor of Traditional Chinese Medicine (BTCM) curriculum in the academic years 1998–1999 to 2001–2002, or the Bachelor of Chinese Medicine (BChinMed) curriculum in September 2002 and thereafter will be eligible to sit for the Chinese Medicine Practitioners Licensing Examination in Hong Kong. Those who have passed the Chinese Medicine Practitioners Licensing Examination are qualified for registration as registered Chinese medicine practitioners with the Chinese Medicine Council of Hong Kong.

Dentistry

The degree of Bachelor of Dental Surgery (BDS) of the University of Hong Kong is recognized as a registrable primary qualification by the Dental Council of Hong Kong (DCHK). The BDS degree has been accredited by the DCHK which has affirmed the specified status of the University of Hong Kong in section 8(1)(b) of the Dentists Registration Ordinance.

Earth Sciences

The BSc (Major in Geology) (Accredited Pathway) has been accredited by the Geological Society of London. This degree provides an accelerated route to validation as a Chartered Geologist after a minimum of five years of relevant post-graduation experience.

The Engineering Geology with the Hong Kong Institution of Engineers (HKIE) Approved Courses Theme of the Master of Science in the field of Applied Geosciences provides the additional courses which graduates in Earth Sciences or Geology would need to meet the entry requirements of the HKIE in the Geotechnical Discipline. These courses have been approved by the HKIE.

Engineering

The degree of BEng in Civil Engineering has been accredited by the Hong Kong Institution of Engineers (HKIE) and the Hong Kong Institute of Construction Managers (HKICM).

The degree of BEng in Civil Engineering (Environmental Engineering) has been accredited by the HKIE and HKICM.

The degree of BEng in Computer Science has been accredited by the HKIE.

The degree of MSc(Eng) in Transportation Engineering has been accredited by the Chartered Institute of Logistics and Transport in Hong Kong for full exemption of the examination requirements leading to the Chartered Membership.

The degrees of BEng in Electrical and Electronic Engineering/Electronic and Communications Engineering, Information Engineering, Electrical Engineering and Computer Engineering have been accredited by the HKIE.

The degree of BEng in Industrial Engineering and Technology Management has been accredited by the HKIE.

The degree of BEng in Logistics Engineering and Supply Chain Management has been accredited by the HKIE and the Chartered Institute of Logistics and Transport (CILT).

The degree of MSc(Eng) in Industrial Engineering and Logistics Management has been accredited by the Chartered Institute of Logistics and Transport in Hong Kong for full exemption from the examination requirements leading to the Chartered Membership.

The degree of BEng in Mechanical Engineering has been accredited by the HKIE.

The degree of BEng in Mechanical Engineering (Building Services Engineering) has been accredited by the HKIE.

The degree of BEng in Medical Engineering has been accredited by the HKIE.

Geography

The Department of Geography, together with the Department of Urban Planning and Design and the Department of Civil Engineering, offer the Master of Arts in Transport Policy and Planning [MA(TranspPol&Plan)] programme. Graduates of the MA(TranspPol&Plan) programme will be exempted automatically from the examination requirements leading to the qualification of Chartered Membership of the Chartered Institute of Logistics and Transport (Hong Kong) (CMILT).

Law

The University and the governing bodies of the legal profession in Hong Kong have agreed upon a scheme of qualification which will lead to admission to practise in Hong Kong for the University's law graduates. After completing the University's Bachelor of Laws degree (LLB) or Juris Doctor (JD), an intending barrister or solicitor will attend further courses at the University and must obtain a Postgraduate Certificate in Laws (PCLL). It will then be necessary for him or her to complete satisfactorily pupillage or a period of employment as a trainee solicitor and attend a specified number of continuing legal education courses in order to qualify for admission to practise as a barrister or solicitor respectively.

Medicine

The degrees of Bachelor of Medicine and Bachelor of Surgery (MBBS) are recognized as registrable primary qualifications by the Medical Council of Hong Kong.

Nursing

The degree of Bachelor of Nursing (BNurs) is recognized as registrable qualification by the Nursing Council of Hong Kong.

Pharmacy

Students who have completed the degree of Bachelor of Pharmacy and one year of internship are qualified to register with the Pharmacy and Poisons Board of Hong Kong as pharmacists in Hong Kong.

Psychology

Recognition has been granted by the Hong Kong Psychological Society to the degree courses in Psychology offered by this University, entitling graduates to graduate membership in the Society. The courses leading to the Master of Social Sciences in Psychology have been similarly recognized.

The courses leading to the Master of Social Sciences in Clinical Psychology and the Master of Social Sciences in Educational Psychology provide professional training in the respective fields, and are recognized by employing bodies in Hong Kong. The courses leading to the PhD with specialization in Clinical Psychology and the PhD with specialization in Educational Psychology are professionally recognized equivalently. All professional Master and PhD programmes are advised by international experts and local advisory committee of leading psychologists in their professions.

Real Estate and Construction

The professional degree of Bachelor of Science in Surveying [BSc(Surv)] is recognized by the Chartered Institute of Building (CIOB), Pacific Association of Quantity Surveyors (PAQS), Royal Institution of Chartered Surveyors (RICS) and the Hong Kong Institute of Surveyors (HKIS), and graduates are admitted to the Institutes' Assessment of Professional Competence.

MSc(ConstProjectMan) including all its majors is recognized by CIOB and RICS. The MSc(ConstProjectMan) programme majoring in Quantity Surveying is accredited by the PAQS and Quantity Surveying Division of HKIS.

MSc(RealEst) including all its majors is recognized by CIOB and RICS. The MSc(RealEst) programme majoring in Facility Management, Planning and Development and General Practice Surveying is accredited by the Property and Facility Management Division, the Planning and Development Division and the General Practice Division of HKIS respectively.

The MSc(IDM) is recognized by CIOB and RICS.

The degree of Bachelor of Arts in Conservation [BA(Conservation)] is recognized by RICS.

Full professional status is gained after an appropriate length of approved practical experience and passing the Institutes' Assessment of Professional Competence which may be taken in Hong Kong.

Social Work

The Department of Social Work and Social Administration offers the Bachelor of Social Work (BSW) degree and the Master of Social Work (MSW) degree programmes. The BSW and MSW programmes are recognized by the Hong Kong Social Workers Registration Board (SWRB) in Hong Kong as accredited social work qualifications.

The Department of Social Work and Social Administration is a member of the International Association of Schools of Social Work, which implies recognition of the standard of the programmes.

Speech and Hearing Sciences

Employing bodies in Hong Kong recognize successful completion of the Bachelor of Science in Speech and Hearing Sciences [BSc(Sp&HearSc)] curriculum as a professional qualification for speech therapists.

Urban Planning and Design

The degree of MSc(UrbanPlanning) is recognized as a professional qualification by the Hong Kong Institute of Planners (HKIP). Full professional status may be gained after two years' approved practical experience, of which at least one year must be in Hong Kong.

The degree of MSc(UrbanPlanning) is also recognized by the Royal Town Planning Institute (RTPI) in the United Kingdom and graduates can become licentiate members to undergo two years of assessment of professional competency to become full corporate members of the Institute.

Graduates of the MSc(UrbanPlanning) programme who specialized in transport planning are also qualified to apply for chartered membership of the Chartered Institute of Logistics and Transport (Hong Kong) (CILT–HK) after they have obtained practical experience at professional level.

Graduates of MSc(UrbanPlanning) who have completed additional real estate modules are eligible for admission to the Assessment of Professional Competence (APC) scheme of the Planning and Development Division of Hong Kong Institute of Surveyors (HKIS) via the non-cognate but relevant graduate degree route. Full professional membership may be granted by the HKIS after they have gained the required working experience and passing the professional assessment.

The Master of Housing Management (MHousMan) (Professional Stream) is recognized by the Chartered Institute of Housing and the Hong Kong Institute of Housing. Graduates of this stream are eligible to apply for Corporate Membership of both Institutes after fulfilling the Practical Experience Requirement (PER).

The Bachelor of Arts in Urban Studies [BA(UrbanStud)] is recognized by the Planning and Development Division of HKIS and the Royal Institution of Chartered Surveyors (RICS).
